District Nos. 1 and 9 were formed December 8, 2020 and District Nos. 2, 3, 4, 5, 6, 7, and 8 were formed on May 20, 2022.

During the Reporting Year the Redlands 360 Metropolitan District Nos. 2, 3, and 9 submitted proposed Orders for Inclusions and Exclusions, and Redlands 360 Metropolitan District No. 4 submitted a proposed Order for Exclusion. The Orders were granted by the Mesa County District Court, and became effective when recorded with the Mesa County Clerk Recorder as set forth below:
