**SUBJECT:**

City Attorney Hiring Process

**EXECUTIVE SUMMARY:**

City Council has directed that the City conduct a City Attorney hiring process similar to the City Manager recruitment, including City Council review of the Request for Proposals (RFP) and City Council selection of the recruitment firm. This workshop item is intended to review the proposed Scope of Services and Deliverables for an executive search firm, so Purchasing can finalize the full RFP package for release.

**BACKGROUND OR DETAILED INFORMATION:**

The City Attorney position is a key executive-level role that provides legal counsel and support to the organization and City Council. Given the level of the position and City Council's desire to use an executive search firm, staff has developed a proposed scope of services and deliverables that sets clear expectations for the recruitment firm's work and the products the City will receive.

This workshop discussion is intentionally focused on the scope of services and deliverables, as these elements reflect the subject-matter expectations for the recruitment process (e.g., recruitment strategy and outreach, development of recruitment materials, screening and candidate summaries, coordination of interviews and finalist support, verification/reference support, and assistance through selection/offer). Purchasing will incorporate City Council direction into the complete RFP package, including solicitation instructions, standard terms and conditions, required forms, and evaluation documentation.

Following release of the RFP and receipt of proposals, staff will return to City Council for consideration and selection of the recruitment firm, consistent with City Council

direction.

**FISCAL IMPACT:**

Cost will be determined through the competitive RFP process and will depend on the selected firm's fee structure and proposed scope. Staff will return to City Council with pricing and a recommended funding source at the time proposals are presented for firm selection.

Provide direction on the proposed scope of services and deliverables for the City Attorney executive search RFP, including any additions or revisions, so staff and Purchasing can finalize and release the RFP and return proposals to City Council for selection of the recruitment firm.

## **City Attorney Executive Search RFP – Scope of Services and Deliverables Draft**

City Council has directed that the City conduct a City Attorney hiring process similar to the City Manager recruitment, including City Council review/approval of the Request for Proposals (RFP) and City Council selection of the recruitment firm. This summary is provided for City Council workshop discussion to outline the expected scope of services and deliverables the City would require from an executive search firm. Procurement will incorporate this scope into the complete RFP package, including solicitation instructions, standard terms and conditions, required forms, and evaluation documentation.

### **Scope of Services (City Attorney Executive Search)**

The selected executive search firm (“Consultant”) shall provide full-service recruitment and selection support for the City Attorney position. Services are expected to include, at minimum:

- **Project Initiation and Recruitment Strategy**
  - Kickoff meeting with City representatives and, as directed, City Council representation
  - Confirm timeline, decision points, roles/responsibilities, and communication cadence
  - Written recruitment strategy (sourcing approach, target markets, outreach channels, risks/mitigation)
- **Position Profile Development and Selection Criteria**
  - Review/refine job description and requirements in coordination with City representatives and City Council direction
  - Facilitate stakeholder input to confirm priorities, qualifications, and job-related selection criteria
  - Assist in defining leadership competencies/behavioral expectations to be used consistently throughout screening and interviews
  - Develop a draft Position Profile/recruitment brochure for City Council review following firm selection
- **Recruitment Marketing and Outreach**
  - Proactive recruitment campaign, including direct sourcing
  - Post/advertise in agreed-upon professional networks and venues
  - Manage candidate inquiries and provide consistent position/process information
- **Application Management and Candidate Screening**
  - Receive/manage applications and inquiries
  - Screen against minimum qualifications and approved criteria/competencies
  - Conduct structured preliminary interviews and prepare written candidate summaries
- **Candidate Assessment and Due Diligence**
  - Coordinate assessment steps as directed by the City/City Council (e.g., structured interviews, written exercise, scenario-based discussion, stakeholder meetings)
  - Conduct finalist reference checks (minimum number as directed)
  - Verify active bar licensure and standing, and education as applicable, consistent with consent and legal requirements
  - Coordinate background checks consistent with applicable laws and City process
- **Interview Process Support and Coordination**

## City Attorney Executive Search RFP – Scope of Services and Deliverables Draft

- Provide structured interview questions aligned to the Position Profile and criteria/competencies
- Provide evaluation tools (score sheets/rubrics) to support consistent, job-related evaluation
- Coordinate interview schedules and candidate logistics as directed by the City
- Provide candidate briefing materials and comparative summaries for interviewers
- Finalist Support, Selection, and Offer Assistance
  - Comparative finalist summaries describing qualifications and demonstrated leadership behaviors relative to approved criteria/competencies, including strengths and areas to explore further
  - Support selection steps and offer development/negotiation within City-approved parameters
  - Manage communications with candidates throughout the final selection process
- Status Updates and Administrative Coordination
  - Weekly or biweekly written status updates (as determined by the City)
  - Candidate communications, scheduling coordination, and process tracking support

### Deliverables

At minimum, the Consultant shall provide:

- Project Workplan and Schedule (milestones, decision points, update cadence)
- Recruitment Strategy Summary (outreach channels, sourcing plan, screening approach)
- Position Profile / Recruitment Brochure (Draft and Final) for publication and outreach
- Recruitment Launch Materials (posting/ad copy and list of recruitment channels used)
- Regular Status Updates (written weekly/bi-weekly pipeline and outreach updates)
- Semifinalist Candidate Report (resumes and written summaries tied to criteria/competencies)
- Finalist Slate and Finalist Packets (typically 3–5 finalists unless market conditions warrant otherwise)
- Interview and Evaluation Materials Package (questions and rubric/score sheets aligned to criteria/competencies, schedules, briefing sheets)
- Reference and Verification Summaries (references and credential verification, including bar status/standing)
- Selection and Offer Support (support through selection, offer negotiation, acceptance)
- Closeout Summary (process/outreach overview, candidate flow, selection outcome, transition considerations)

##### **SUBJECT:**

Boards and Commissions Decision Making Process

##### **EXECUTIVE SUMMARY:**

Community participation at all levels of the governmental process is valued and encouraged. The City Clerk's office helps facilitate volunteer appointments to 14 boards, committees, commissions, and authorities on which over 100 citizens serve. Boards and Commission members are appointed by interview teams composed of two Councilmembers and their chair. This topic was requested for Council discussion to visit the Council decision-making process and its communication to the rest of the Council prior to going to a vote during a regular meeting.

##### **BACKGROUND OR DETAILED INFORMATION:**

Recruitment and onboarding for the city's boards and commissions are ongoing throughout the year for each board, and are also conducted when there is a resignation. Three months before the terms expire, the City Clerk's Office notifies the individuals and the staff liaison regarding the term expiration and whether they are eligible to reapply. If the member is interested in continuing to serve, we ask them to complete an application linked in the email. If the member is term-limited, they are not eligible to reapply and will receive a letter and certificate.

##### **Process Summary:**

- Three months before the terms expire, the vacancies are advertised, and eligible members are asked to reapply.
- Interview teams are determined at council workshops as necessary and consist of the Council Liaison and a second Councilmember.
- After the interview team has been established, a date is selected via a Doodle Poll.

- The board chair is invited to sit on the interview committee. If they are not available, the co-chair or another member is asked to participate.
- Applicants are notified of the interview date and time.
- An interview packet is provided to the interview team via email on the Friday before the interview date for review and in person during the interviews.
- The interview committee chooses its selections for appointments and provides the names to the City Clerk's Office.
- Appointments are scheduled on the agenda for the following regular council meeting.
- The applicants cannot be contacted regarding the status of the appointments until they are completed at the council meeting. For multi-jurisdictional boards, the appointments are ratified by all jurisdictions.
- Letters and certificates are created and mailed the day after the council meeting, and successful applicants are contacted by phone and email.
- The interview team can select an unsuccessful applicant as a backup in case of a mid-year vacancy and/or to contact them for the next interview date.

Orchard Mesa Pool Next Steps

**EXECUTIVE SUMMARY:**

City Council requested the Orchard Mesa Pool item come back to City Council in early 2026 for further discussion. With the expiration of the current agreement with the owner of the land and the building, School District #51, slated for December 31, 2026 and with the Community Recreation Center coming online in late 2026, continued discussion is needed. At the February 2, 2026 workshop, staff presented the history of the facility, described the current situation including level of service and finances, and reviewed the 2023 Orchard Mesa Study and Plan.

After lengthy discussion, Council directed staff to further explore the following options:

Prepare to release a Request for Proposals (RFP) to find a partner/s to take over ownership and operation of the pool and potentially add in new assets to the site. Also, to explore steps to establish a some form of district in Orchard Mesa or larger portion of unincorporated Mesa County to take over ownership, operations and maintenance of the Orchard Mesa Pool.

**BACKGROUND OR DETAILED INFORMATION:**

Since the February 2 workshop, connections have been made with current pool partner, School District #51, as well as with previous pool partner Mesa County, who would need to be the referring entity for a ballot proposal to pursue option D, a special district.

The request for proposals is being drafted per Council direction. Additional guidance is being sought from City Council at the March 2 workshop to better understand who should receive the RFP and what it should entail. In addition to all of the normal

channels of distribution such as on Bid Net, the purchasing division will complete a direct send of the RFP to anyone and any entity the City believes may be interested in. Currently, the recipient list includes Power Wellness (a facility management firm that contacted the City after the Daily Sentinel article that covered the February 2nd workshop), Ninjacross (a firm that provides a pool amenity that involves an obstacle course, who contacted the City after the Daily Sentinel article that covered the February 2nd workshop), Mesa County Library District, Monument Physical Therapy, Physical Therapy Specialty Center, Optimal Performance PT, Fyzical Therapy and Balance Centers, Two Rivers Physical Therapy, Family Health West, Western Slope Rehab and Balance Centers, PT Link Physical Therapy, Primary Care Partners, Community Hospital and St. Mary's Hospital. It is important to note that School District #51, as the owner of the land and the building, would need to approve any contract or otherwise that may come out of this exploration of potential partnerships.

Additionally, staff will report on work completed looking into the creation of a district by a vote of district residents to own and operate the pool and any other facilities listed in the requisite service plan. This includes voting patterns of the Orchard Mesa Council District, where 42% of voters said yes to the 2019 ballot proposal that would have funded the Community Recreation Center at Matchett Park, developed 75 acres of Matchett Park and also renovated the Orchard Mesa Pool and Gym into a satellite recreation center. This compares with 61% of the Orchard Mesa Council district residents who voted yes for the 2023 ballot proposal that successfully funded only the Community Recreation Center at Matchett Park.

Staff will present two possibilities for a district. Option A focuses on Orchard Mesa, where 8,131 residents are City residents and 8,160 are non-City residents. Option B focuses on unincorporated Mesa County on the east side of Mesa County, where there are 16,018 City residents and 44,502 non-City residents. This includes Orchard Mesa, Pear Park, Fruitvale and Clifton. A special district attorney was also contacted to understand what work would be required to submit a ballot proposal to voters to create a special district. It is important to note that creation of such a district would need to be engaged by Mesa County and if Council would like to pursue, discussions need to begin with Mesa County.

Lastly, the project costs included as a part of the 2023 Orchard Mesa Pool study were evaluated by FCI Constructors, the results of which will be presented at the March 2nd workshop.

**FISCAL IMPACT:**

The 2026 budget includes funding for the Orchard Mesa Pool per the agreement with School District #51 to operate the facility until at least until the CRC opens. It is of note that the City's payment has risen each year, from \$125,000 in 2022 to \$441,444 in 2026 (budgeted). Without contributions from Mesa County and School District #51, the City is now fully responsible for covering the required subsidy. The 2026 budget also reflects reductions in operational revenue, as the 2023 Orchard Mesa Pool study projects a 2/3 decrease in participation once the CRC opens in Q4 2026.
