QUIT CLAIM DEED

THIS DEED, Made this 25th day of February, 1953, between BURRELL C. REYNOLDS, duly qualified and elected Treasurer and Public Trustee of Mesa County, Colorado, party of the first part, and the City of Grand Junction, Colorado, party of the second part, Witnesseth:

That the said party of the first part for and in consideration of Ten (\$10) Dollars and other good and valuable considerations and by virtue and by authority of Section 155 of Chapter 40, 1935 Colorado Statutes Annotated, has hereby released, conveyed and quit claim unto the second party all title rights and interest that first party as public trustee, has in the property hereinafter described.

The last conveyance on record regarding this property shows a Warranty Deed from Charles A. Armstrong to Charles B. Rich and Monroe L. Allison as Trustees of the estate of George A.
