WARRANTY DEED

Dianne Hauck, Grantor, for and in consideration of the sum of Four Hundred Twenty-Four and 50/100 Dollars (\$424.50), the receipt and sufficiency of which is hereby acknowledged, has sold, granted and conveyed, and by these presents does hereby sell, grant and convey to The City of Grand Junction, a Colorado home rule municipality, whose address is 250 North 5th Street, Grand Junction, Colorado 81501, Grantee, its successors and assigns forever, the following described tract or parcel of land for Public Roadway and Utilities Right-of-Way purposes, to wit:

A tract or parcel of land for Public Roadway & Utilities Right-of-Way purposes, situate in the Southeast 1/4 (SE 1/4) of Section 7, Township 1 South, Range 1 East of the Ute Meridian, City of Grand Junction, County of Mesa, State of Colorado, being more particularly described as follows, to wit:

Beginning at the Northeast Corner of Lot 1, Block 1 of Epps Subdivision, situate in the SE 1/4 of said Section 7 as recorded in Plat Book 7 at Page 3 in the office of the Mesa County Clerk and Recorder, and considering east line of the SE 1/4 of said Section 7 to bear S 00°03'46" E with all bearings contained herein being relative thereto;
thence S 00°03'46" E along the east boundary line of said Lot 1 a distance of 17.69 feet;
thence leaving the east boundary line of said Lot 1, N 42°11'25" W a distance of 23.86 feet to a point on the north boundary line of said Lot 1;
thence N 89°56'20" E along the north boundary line of said Lot 1 a distance of 16.00 feet to the Point of Beginning,

containing 141.50 square feet as described herein and depicted on **Exhibit "A"** attached hereto and incorporated herein by reference.

TO HAVE AND TO HOLD the premises aforesaid, with all and singular the rights, privileges, appurtenances and immunities thereunto belonging or in anywise appertaining, unto the said Grantee and unto its successors and assigns forever, the said Grantor hereby covenanting that she will warrant and defend the title to said premises unto the said Grantee and unto its successors and assigns forever, against the lawful claims and demands of all persons whomsoever.

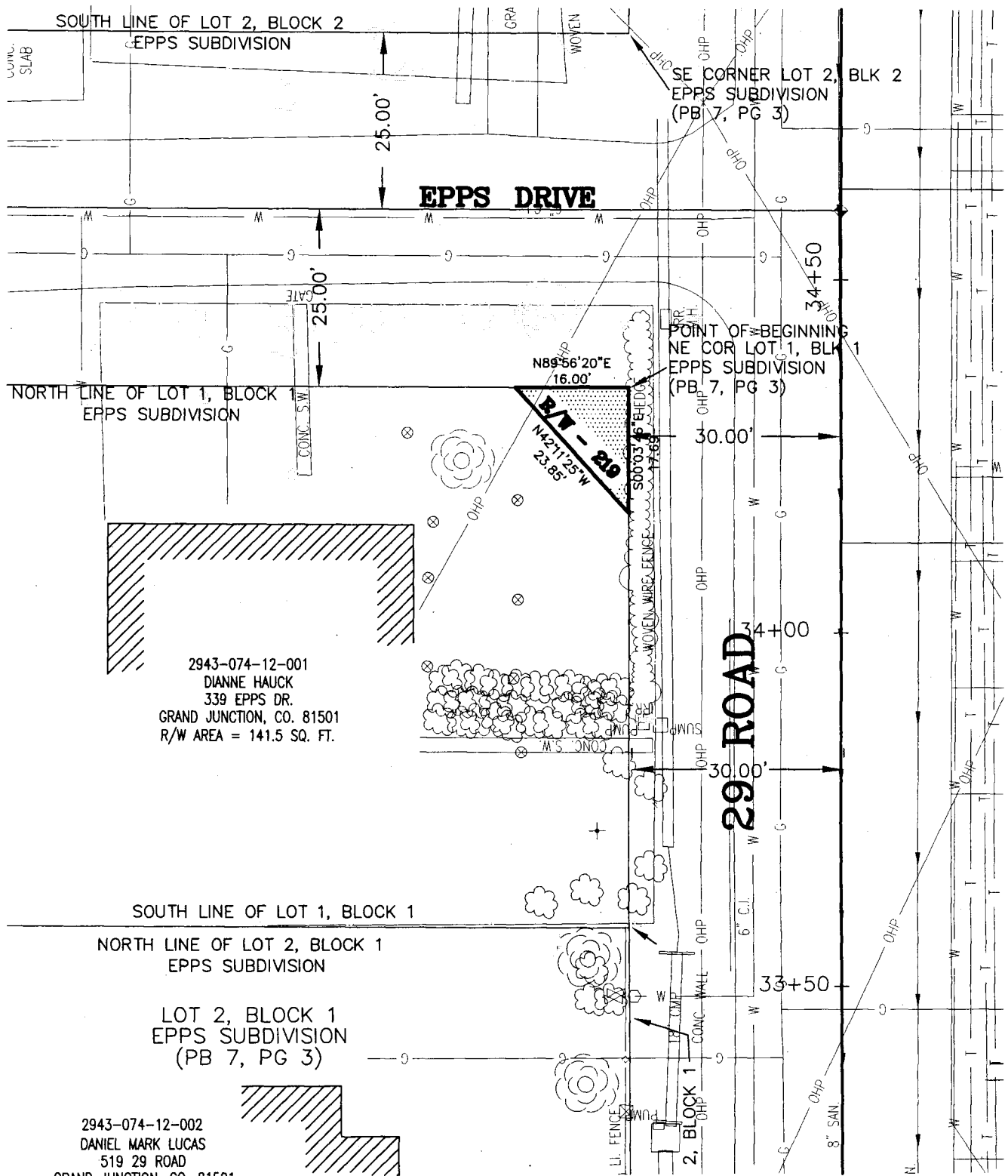
