The west half (W2) of Block ninety-five (95) of the City of Grand Junction, Mesa County, Colorado, according to the recorded plat thereof, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD All and singular the above-described premises, together with the appurtenances, unto said second party and its assigns, forever.
