CORRECTION OF DEED

THIS INDENTURE made this <u>21</u>th day of <u>June</u>, 2000, between the UNITED STATES OF AMERICA, acting by and through the SECRETARY OF VETERANS AFFAIRS, hereinafter called the "Grantor," and the City of Grand Junction, Colorado, hereinafter called the "Grantee."

WITNESSETH

WHEREAS, by Public Law 84-579, approved June 13, 1956, the Administrator of Veterans Affairs was authorized and directed to convey to the City of Grand Junction, Colorado, a tract of land containing 16.72 acres of land, more or less, situated at the Veterans Administration Hospital at Grand Junction; and

WHEREAS, by Quitclaim Deed dated November 19, 1956, and recorded on January 30, 1957, in the Office of the County Clerk, Mesa County, Colorado, in Book 702 of Deeds at page 246, certain real property containing 16.72 acres, more or less, and more particularly described therein, was conveyed by the Grantor in accordance with, and pursuant to said Public Law 84-579, approved June 13, 1956, to the Grantee for park and recreational purposes and subject also to certain other restrictions, reservations, and conditions, contained therein; and

WHEREAS, the Grantor did by Correction of Deed dated July 25, 1974, and recorded on August 28, 1974, in the Office of the County Clerk, Mesa County, Colorado, in Book 1022 of Deeds at page 697, thereby redefine and correct the Quitclaim Deed dated November 19, 1956; and

WHEREAS, the Grantor and Grantee do hereby agree that it would be mutually advantageous and desirable to again correct the conveyance heretofore conveyed so as to reserve to the Grantor an easement for the purpose of maintaining and repairing a sanitation and storm sewer line running from the VA Medical Center, Grand Junction, Colorado, to and through points more specifically delineated in Exhibits A, B, and C, which are hereby attached and made a part hereof;

NOW THEREFORE, the tract of land containing 16.72 acres, more or less, heretofore conveyed by said Quitclaim Deed dated November 19, 1956, and redefined by Correction of Deed dated July 25, 1974, is hereby again corrected as follows:

The United States of America, acting by and through the Secretary of Veterans Affairs, reserves unto itself an exclusive easement and right of way to enter, for the purposes of constructing, reconstructing, extending, inspecting, repairing, and maintaining, as it may from time to time require, certain portions of land which the undersigned conveyed by the above said Deeds and are delineated in Exhibits A, B, and C, attached hereto and made a part hereof.

All other restrictions, reservations, and conditions contained in said Quitclaim Deed dated November 19, 1956, and the Correction of Deed dated July 25, 1974, shall remain in full force and effect.
