GRANT OF MULTI-PURPOSE EASEMENT

Glen R. Dean, Grantor, whose address is 2655 G 1/2 Road, Grand Junction, CO 81506, for and in consideration of the sum of Ten and 00/100 Dollars (\$10.00), the receipt and sufficiency of which is hereby acknowledged, has granted and conveyed, and by these presents does hereby grant and convey to the City of Grand Junction, a Colorado home rule municipality, Grantee, whose address is 250 North 5th Street, Grand Junction, Colorado 81501, a Perpetual Multi-Purpose Easement for the use and benefit of Grantee and for the use and benefit of the Public Utilities, as approved by Grantee, as a perpetual easement for the installation, operation, maintenance, repair and replacement of utilities and appurtenances related thereto, including, but not limited to, electric lines, cable television lines, natural gas pipelines, sanitary sewer lines, storm sewers and storm water drainage facilities, irrigation and drainage facilities, water lines, telephone lines, and also for the installation, operation maintenance, repair and replacement of traffic control facilities, street lighting, landscaping, trees and grade structures, as approved by Grantee, on, along, over, under, through and across the following described parcel of land, to wit:

A certain strip of land for easement purposes as described in Exhibit "A" and depicted on Exhibit "B" attached hereto and incorporated herein by reference.

TO HAVE AND TO HOLD unto the said Grantee, its successors and assigns forever, together with the right to enter upon said premises with workers and equipment, to survey, maintain, operate, repair, replace, control and use said Easement, and to remove objects interfering therewith, including the trimming of trees and bushes as may be required to permit the operation of standard construction and repair machinery, subject to the terms and conditions contained herein.

- The interest conveyed is an Easement for the limited purposes and uses and upon the terms stated herein. Grantor reserves the right to use and occupy the real property burdened by this Easement for any lawful purpose which is not inconsistent with and which will not substantially interfere with the full use and quiet enjoyment of the rights herein granted; provided, however, that Grantor hereby covenants with Grantee that the Easement shall not be burdened or overburdened by the installation, construction or placement of any improvements, structures or fixtures thereon which may be detrimental to the facilities of Grantee or which may act to prevent reasonable ingress and egress for workers and equipment on, along, over, under, through and across the Easement.
- Grantor hereby covenants with Grantee he has good title to the herein described premises; that he has good and lawful right to grant this Easement; that he will warrant and forever defend the title and quiet possession thereof against the lawful claims and demands of all persons whomsoever.

A Multi-Purpose Easement in Lot 1 of Miller Subdivision, Plat Book 13 Page 404, situate in the SW1/4 SE1/4 of section 3 in Township One South, Range One West of the Ute Meridian in the City of Grand Junction, Mesa County, Colorado, said portion being more particularly described as follows:

Commencing at a Mesa County Survey Marker for the South 1/4 Corner of said Section 3; whence a Mesa County Survey Marker for the Southeast corner of said section bears S89°55'03"E a distance of 2638.09 feet; thence S89°55'03"E along the south line of said section, for a distance of 217.75 feet; thence N00°04'57"E a distance of 40.28 feet to a point on the northerly right-of-way line of Patterson Road, and the southeast corner of said Lot 1; thence N00°02'39"E a distance of 6.00 feet along the easterly line of said Lot 1 to the Point of Beginning; thence the following:

- 1. Westerly 2.97 feet on the arc of a non-tangent 893.50-foot radius curve to the right subtended by a central angle of 00°11'26" and having a chord which bears N88°22'37"W a distance of 2.97 feet
- 2. N84°23'11"W for a distance of 79.85 feet;
- 3. Along a curve to the left 82.66 feet on the arc of a 889.50-foot radius curve subtended by a central angle of 05°19'28" and having a chord which bears N87°02'54"W a distance of 82.63 feet;
- 4. N89°42'38"W for a distance of 18.75 feet, to a point on the northerly right-of-way of Patterson Road;
- 5. Northwesterly along said right-of-way N44°55'03"W for a distance of 1.49 feet, to a point on the easterly right-of-way of 25 ½ Road;
- 6. Along said right-of-way, N00°03'04"E for a distance of 200.68 feet, to the northwest corner of said Lot 1:
- 7. Along northerly line of said Lot 1, S89°55'03"E for a distance of 14.00 feet;
- 8. Departing northerly line of said Lot 1 running parallel with westerly line of said Lot 1, S00°03'04"W for a distance of 187.80 feet;
- 9. Along a non tangent curve to the right 89.82 feet on the arc of a 903.50-foot radius curve subtended by a central angle of 05°41'45" and having a chord which bears S87°14'03"E a distance of 89.78 feet;

- 11. Along a curve to the left 2.09 feet on the arc of a 879.50-foot radius curve subtended by a central angle of 00°08'10" and having a chord which bears S88°22'50"E a distance of 2.09 feet, to a point on the easterly line of said Lot 1:
