The installation of said sanitary sewer line will be made by 2. the City and its contractors at no cost to the Vendors.

In consideration for the parcels of land described herein, the 3. City, as managers of the 201 Sewer System agrees to:

Waive the Plant Investment Fee for two (2) single family Α. residential sewer taps to the property which is to be encumbered by the above referenced easements, having a present dollar value of \$1,500.00,

B. Waive any and all assessments or capital improvement charges associated with the costs of extending public sanitary sewer across the above referenced Permanent Easement for two (2) single family residential sewer taps.

This agreement shall be deemed a contract extending to and binding upon the parties hereto, and upon their heirs, successors and assigns.

This Temporary Construction Easement Agreement is entered into this 15^{-1} day of 1a and 199, by and between Clarence L. Files, Shirley A. Howard, Donald G. Files and Robert L. Files, hereinafter referred to as the "Vendors", and The City of Grand Junction, a municipal corporation, hereinafter referred to as the "City";

WHEREAS, in the installation a sanitary sewer line and related facilities, the City requires the Temporary Construction Easement more particularly described as follows, to wit:

The West 50.0 feet of the NE1/4 NE1/4 of the SW1/4 of Section 2, Township 1 South, Range 1 West of the Ute Meridian, Mesa County, Colorado, lying South of the right of way of the Canal of the Grand Valley Irrigation Company.

NOW, THEREFORE, IT IS AGREED:

1. For the consideration of One Dollar (\$1.00) and other good and valuable consideration, the Vendors convey to the City said temporary construction easement to allow access for construction workers and equipment to install said sanitary sewer line and related facilities.

2. Said temporary easement will commence on the first date of the construction of the above referenced project and terminate when construction of said project is completed and formally accepted by the City Engineer.

3. It is not the City's intent to disturb the surface of the ground or any other appurtenances presently existing on the Vendor's property; however, if any such appurtenances are disturbed from said construction activities of the project, they shall be returned as nearly as practicable to their original condition, or better.

4. This Agreement shall be deemed a contract extending to and binding upon the parties hereto, and upon their respective heirs, devisees, executors, administrators, legal representatives, successors and assigns, subject to City approval.
