

GRANT OF STREET LIGHT EASEMENTS

Jans Corp., a Colorado corporation, Grantor, for and in consideration of the sum of Thirty Eight and 26/00 Dollars (\$38.26), the receipt and sufficiency of which is hereby acknowledged, has sold, granted and conveyed, and by these presents does hereby sell, grant, and convey to the City of Grand Junction, a Colorado home rule municipality, Grantee, whose address is 250 North 5th Street, Grand Junction, Colorado, 81501, for the use of Grantee and for the use of the Public Utilities, two (2) Perpetual Easements for the installation, operation, maintenance, repair and replacement of street lights, together with facilities appurtenant thereto, on, along, over, under, through and across the following described parcels of land, to wit:

Street Light Easement A:

Commencing at the Northeast Corner of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 1, Township 1 South, Range 1 West of the Ute Meridian, City of Grand Junction, County of Mesa, State of Colorado, and considering the East line of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 1 to bear N 00°02'19" E with all bearings contained herein being relative thereto; thence S 00°02'19" W along the East line of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 1 a distance of 499.49 feet; thence leaving the East line of said SE $\frac{1}{4}$ SW $\frac{1}{4}$, N 89° 57'41" W a distance of 30.00 feet to a point on the West right-of-way line for 27 $\frac{1}{2}$ Road, said point being the <u>True Point of Beginning</u>;

thence S 00°02'19" W along the West right-of-way line for 27 1/2 Road a distance of 5.00 feet;

thence leaving said right-of-way line, N 89°57'41" W a distance of 5.00 feet;

thence N 00°02'19" E a distance of 5.00 feet;

thence S 89°57'41" E a distance of 5.00 feet to the Point of Beginning,

containing 25.00 square feet as described herein and as depicted on **Exhibit "A"** attached hereto and incorporated herein by reference; and also

Street Light Easement B:

Commencing at the Northeast Corner of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 1, Township 1 South, Range 1 West of the Ute Meridian, City of Grand Junction, County of Mesa, State of Colorado, and considering the East line of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 1 to bear N 00°02'19" E with all bearings contained herein being relative thereto; thence S 00°02'19" W along the East line of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 1 a distance of 159.49 feet; thence leaving the East line of said SE $\frac{1}{4}$ SW $\frac{1}{4}$, N 89°57'41" W a distance of 30.00 feet to a point on the West right-of-way line for 27 $\frac{1}{2}$ Road, said point being the <u>True Point of Beginning</u>:

thence S 00°02'19" W along the West right-of-way line for 27 1/2 Road a distance of 5.00 feet;

thence leaving said right-of-way line, N 89°57'41" W a distance of 5.00 feet;

thence N 00°02'19" E a distance of 5.00 feet;

thence S 89°57'41" E a distance of 5.00 feet to the Point of Beginning,

containing 25.00 square feet as described herein and depicted on Exhibit "A" attached hereto and incorporated herein by reference.

TO HAVE AND TO HOLD unto the said Grantee, its successors and assigns forever, together with the right of ingress and egress for workers and equipment to survey, maintain, operate, repair, replace, control, and use said Easements, and to remove objects interfering therewith, including the trimming of trees and bushes as may be required to permit the operation of standard utility construction and repair machinery, subject to the terms and considerations contained herein.

1. Grantor shall have the right to use and occupy the real property burdened by these Easements for any lawful purpose which is not inconsistent with and which will not interfere with the full use and quiet enjoyment of the rights herein granted; provided, however, that Grantor hereby covenants with Grantee that the Easement areas shall not be burdened or overburdened by the installation, construction or placement of any structures or any other item or fixture which might be detrimental to the street lights and appurtenant facilities situate therein, or which might act to prevent reasonable ingress and egress for workers and equipment on, along, over, under, through and across the Easement areas.

2. Grantee agrees that Grantees' utilization of the Easements shall be performed with due care using commonly accepted standards and techniques.

3. Grantor hereby covenants with Grantee that it has good title to the aforedescribed premises; that it has good and lawful right to grant these Easements; that it will warrant and forever defend the title and quiet possession thereof against the lawful claims and demands of all persons whomsoever.
