RIGHT-OF-WAY AGREEMENT

County of Mesa, State of Colorado, herein called Grantor, for good and valuable consideration, the receipt of which is hereby acknowledged, does hereby grant and convey to the City of Grand Junction, a municiple corporation existing under and by virtue of the laws of the State of Colorado, herein called Grantee, a right-of-way to locate, place, construct, operate, repair and maintain an underground sanitary sewer pipe line over, on across and under the following described lands, to wit:

A sewer pipe line twenty (20) feet in width, ten (10) feet each side of a center line described as: Beginning at a point on the West line of Lot 39, Block 23, Benton Canons Addition to Orchard Mesa Heights; Whence the NW Cor. Lot 39 bears North 18.6 feet; Progressing thence South 60 35' E 181.4 feet to a point on the South line of Lot 32; Being 20.9 feet East of the SW Cor Lot 32, Block 23, Benton Canons Add to Orchard Mesa Heights Sub, extending and shortening the side lines so as to terminate at the property lines.
