FIGHT-OF-WAY AGENTACIT

THIS IGHERMENT, made this 23 rd day of Securber, 1928, between Mathias J. Kost, Fose C. Kost and Melvin F. Dehellenberg of the County of Mesa and State of Colorado, first parties, and the City of Grand Junction, Colorado, second party, WITNESSETH:

THAT MARKIAS the first parties are the owners of acparate parcels of land which together comprise that portion of the SW4 of Lot 3, Grandview Subidivision, in the City of Grand Junction, Mess County, Colorado, which will be traversed by the essement hereinsfter described;

and the second party desires to obtain from the first parties, a right-of-way scross said tract, which right-of-way is more particularly described hereafter, for the construction, maintenance and operation of sewer and water lines and other public utility transmission facilities;

MOW THENEFOFE, in consideration of the sum of One Pollar paid to the first parties, the receipt whereof is hereby confessed and admostledged, and other valuable considerations, the first parties to hereby give and grant to the second party the right to lay, maintain, operate, repair and remove sewer pipes, water lines, electrical transmission lines, telephone lines, and other public utility transmission facilities, together with the right of ingress and egress to and from said right-of-way for all of the aforesaid purposes, through and over the following-described land, to-wit:

a strip of land 15 feet in width, lying $7\frac{1}{2}$ feet on each side of a center line which is described as follows: Beginning at a point or the West line of the $SW_{\overline{4}}$ of Lot 3, Grandview Subdivision, which point is 187.03 feet North of the center line of North Avenue in the City of Grand Junction, thence East on a line parallel to the center line of North Avenue, to the East line of said $SW_{\overline{4}}$ of Lot 3, Grandview Subdivision; also beginning at a point 187.03 feet North of the center line of North Avenue and 170.5 feet East of the center line of 15th Street in the City of Grand Junction; thence North on a line parallel to said center line of 15th Street to the South line of Glenwood Avenue. All easements in the $SW_{\overline{4}}$ of Lot 3, Grandview Subdivision.
