Commencing at a Mesa County Brass Cap set for the Southwest Corner of the Northwest ¼ of the Southwest ¼ of the Southwest ¼ (NW¼ SW¼ SW¼) of Section 1, Township 1 South, Range 1 West of the Ute Meridian, City of Grand Junction, County of Mesa, State of Colorado, from whence a Mesa County Brass Cap set for the Northwest Corner of the NW¼ SW¼ SW¼ SW¼ of said Section 1 bears

N 00°04'41" E a distance of 659.19 feet, with all bearings contained herein being relative thereto; thence N 00°04'41" E along the West line of the NW¹/4 SW¹/4 SW¹/4 of said Section 1 a distance of 350.00 feet; thence leaving the West line of said NW ¹/4 SW ¹/4 SW ¹/4, S 89°55'19" E a distance of 30.00 feet to a point being the southwest corner of that certain real property conveyed to Grantor by Warranty Deed dated the 23rd day of July, 1998, and recorded in Book 2468 at Pages 119 and 120 in the office of the Mesa County Clerk and Recorder; thence N 44°34'41" E a distance of 9.99 feet along the southerly boundary line of said real property, thence leaving said southerly boundary line, N00°04'41"E a distance of 29.59 feet to the <u>True Point of Beginning;</u>

thence N 00°04'41" E a distance of 10.49 feet to a point;

thence N 72°25'25" E a distance of 52.97 feet to a point;

thence N 00°00'00" E a distance of 10.55 feet to a point;

thence N 90°00'00" E a distance of 5.00 feet to a point;

thence S 00°00'00" W a distance of 19.45 feet to a point;

thence S 72°25'25" W to the Point of Beginning;

containing 631.04 square feet as described herein and as depicted on **Exhibit "A"** attached hereto and incorporated herein by reference.

TO HAVE AND TO HOLD unto the said Grantee, its successors and assigns forever, together with the right of ingress and egress for workers and equipment to survey, maintain, operate, repair, replace, control and use said Easement, and to remove objects interfering therewith, including the trimming of trees and bushes as may be required to permit the operation of standard utility construction and repair machinery, subject to the terms and conditions contained herein.

1. Grantor shall have the right to use and occupy the real property burdened by this Easement for any lawful purpose which is not inconsistent with and which will not interfere with the full use and quiet enjoyment of the rights herein granted; provided, however, that Grantor hereby covenants with Grantee that the Easement area shall not be burdened or overburdened by the installation, construction or placement of any structures or any other item or fixture which might act to prevent reasonable ingress and egress for workers and equipment on, along, over, under, through and across the Easement area.

2. Grantee agrees that Grantees' utilization of the Easement shall be performed with due care using commonly accepted standards and techniques.

3. Grantor hereby covenants with Grantee that it has good title to the aforedescribed premises; that it has good and lawful right to grant this Easement; that it will warrant and forever defend the title and quiet possession thereof against the lawful claims and demands of all persons whomsoever.


