RIGHT-OF-WAY AGREEMENT

THIS AGREEMENT, made this 24 day of October, 1947,

between Loyd Files, Clarence Files, Royal Ramey and Lucille M. Ramey, of the County of Mesa and State of Colorado, first parties, and the City of Grand Junction, Colorado, second party, WITNESSETH:

THAT WHEREAS the first parties are the owners of separate parcels of land which together comprise the following-described tract:

> The SE $_{4}$ SW $_{4}$ SE $_{4}$ of Section 12, Township 1 South, Range 1 West of the Ute Meridian in Mesa County, Colorado, except the East 2 acres thereof;

AND WHERFAS the first parties desire to convey to the second party, and the second party desires to obtain from the first parties, a right-of-way across the above-described tract, which right-of-way is more particularly described hereafter, for the construction, maintenance and operation of sever and water lines and other public utility transmission facilities;

NOW THEREFORE, in consideration of the sum of One Bollar paid to the first parties, the receipt whereof is hereby confessed and acknowledged, and other valuable considerations, the first parties do hereby give and grant to the second party the right to lay, maintain, operate, repair and remove sewer pipes, water lines, electrical transmission lines, telephone lines, and other public utility transmission facilities, together with the right of ingress and egress to and from said right-of-way for all of the aforesaid purposes, through and over the following-described land, to-wit:

> A strip of land 15 feet in width, lying $7\frac{1}{2}$ feet on each side of a center line which is described as follows: Beginning at a point which is 662.77 feet East and 330 feet North of the South Quarter corner of said Section 12, thence in an Easterly direction to a point on the West line of the East 2 acres of said $SE_{\overline{4}}$ $SW_{\overline{4}}^{\perp}$ $SE_{\overline{4}}^{\perp}$ of Section 12, which is 330 feet North of the center line of North Avenue, in the City of Grand Junction;
