Dear Sir:

Referring to your letter of November 19, 1947, in regard to release of easement approved by the City of Grand Junction, covering a strip of land adjacent to the Veterans Administration Hospital property in Grand Junction, please be advised that we sent the fully executed copy to Mr. Algen B. Wurtsbaugh and he returned the same with the request that a portion of the fifth, sixth and seventh lines of the fifth paragraph of the instrument be changed to read as follows: After the word "grant" in the third line at the top of page 2, change to read" and convey an easement for highway pruposes to the said Gity on and over a strip of land 20 ft., in width." and then follow with the word "adjacent," etc.

I am handing you three revised second pages as per Mr. Wurtsbaugh's request, since the Atterney General says this is O.K. if it is acceptable to the City.
