RIGHT-OF-WAY AGREEMENT

THIS AGREEMENT, made this _____ day of December, 1947, between Ernest T. Sparn of the County of Mess and State of Colorado, first party, and the City of Grand Junction, Colorado, second party, WITNESSETH:

THAT WHEREAS the first party is the owner of the followingdescribed tract of land:

> The East $6\frac{1}{2}$ acres of the Northwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of the South east $\frac{1}{4}$ of Section 12, Township 1 South, Range 1 West of the Ute Meridian, Mesa County, Colorado;

AND WHEREAS the first party desires to convey to the second party, and the second party desires to obtain from the first party, a right-of-way across said tract, which right-of-way is more particularly described hereafter, for the construction, maintenance and operation of sever and water lines and other public utility transmission facilities;

NOW THEREFORE, in consideration of the sum of One Dollar paid to the first party, the receipt whereof is hereby confessed and acknowledged, and other valuable considerations, the first party does hereby give and grant to the second party the right to lay, maintain, operate, repair and remove sever pipes, water lines, electrical transmission lines, telephone lines, and other public utility transmission facilities, together with the right of ingress and egress to and from said rightof-way for all of the aforesaid purposes, through and over the followingdescribed land, to-wit:
