RIGHT-OF-WAY AGREEMENT

THAT WHEFEAS the first party is the owner of a parcel of land lying in the North one-half of Lot 2, Grandview Subdivision, in the City of Grand Junction, Mesa County, Colorado, which will be traversed by the easement hereinafter described;

AND WHEREAS the first party desires to convey to the second party, and the second party desires to obtain from the first party, a right-of-way across the said tract, which right-of-way is more particularly described hereafter, for the construction, maintenance and operation of sewer and water lines and other public utility transmission facilities;

NOW THEREFORE, in consideration of the sum of One Dollar paid to the first party, and receipt whereof is hereby confessed and acknowledged, and other valuable considerations, the first party does hereby give and grant to the second party the right to lay, maintain, operate, repair and remove sewer pipes, water lines, electrical transmission lines, telephone lines, and other public utility transmission facilities, together with the right of ingress and egress to and from said right-of-way for all of the aforesaid purposes, through and over the following-described land, to-wit:

A strip of land 15 feet in width, lying 7.5 feet on each side of an east-west center line which is 505.2 feet north of and parallel to the south line of Section 12, Township 1 South, Range 1 West, of the Ute Meridian, across the following described tract: Beginning at a point 329.8 feet south and 265 feet west of the northeast corner of Lot 2, Grandview Subdivision, thence west 43.96 feet, thence north 229 feet, thence east 43.96 feet, thence south to the point of beginning.
