RIGHT-OF-WAY AGREEMENT

THIS AGREEMENT, made this <u>29</u> asy of November, 1947, between Charles J. Weber of the County of Mess and State of Colorado, first party, and the City of Grand Junction, Colorado, second party, WITNESSETH:

THAT WHEREAS the first party is the owner of the following-described tract of land:

The West 1/2 of the North 1/2 of the South 1/2 of Lot 7, Grandview Subdivision in the City of Grand Junction, Mesa County, Colorado;

AND WHEREAS the first party desires to convey to the second party, and the second party desires to obtain from the first party, a right-of-way across the above-described tract, which right-of-way is more particularly described hereafter, for the construction, maintenance and operation of sewer and water lines and other public utility transmission facilities;

NOW THEREFORE, in consideration of the sum of One Dollar paid to the first party, the receipt whereof is hereby confessed and acknowledged, and other valuable considerations, the first party does hereby give and grant to the second party the right to lay, maintain, operate, repair and remove sever pipes, water lines, electrical transmission lines, telephone lines, and other public utility transmission facilities, together with the right of ingress and egress to and from said right-of-way for all of the aforesaid purposes, through and over the following-described land, to-wit:

A strip of land 20 feet in width, lying 10 feet on each side of a center line which is described as follows: Beginning at a point 170.1 feet north of the Southwest corner of said Lot 7, thence in an easterly direction to a point which is 154 feet west of the center line of 15th Street in the City of Grand Junction, said line to be parallel to and North of the center line of proposed Bunting Avenue in the City of Grand Junction;
