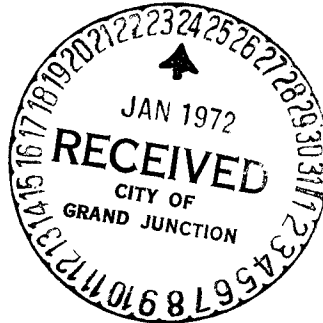

A G R E E M E N T

THIS AGREEMENT, Entered into this 4th day of January, 1972, by and between the STATE DEPARTMENT OF HIGHWAYS, DIVISION OF HIGHWAYS, STATE OF COLORADO, hereinafter called the "Division," and the CITY OF GRAND JUNCTION, hereinafter called the "City,"

WITNESSETH THAT:

WHEREAS, the parties hereto have indicated a willingness to cooperate in the beautification of the easterly S.H. 70 approach to the City, and

WHEREAS, the Division is contemplating improvement of the Federal-aid Primary System on S.H. 70 designated as Project F 070-1(1), beginning at Thirteenth Street and extending easterly 2.84 miles to the Fruitvale intersection, and

WHEREAS, plans and specifications for aforementioned Project F 070-1(1) shall include items for a sprinkling system, seeding, and ornamental lighting of areas previously agreed upon by City Engineer, City's Director of Parks and Recreation, and Traffic Engineer,

NOW, THEREFORE, in consideration of the premises and mutual covenants and agreements herein contained, and faithful performance thereof, the parties hereto promise and agree as follows:

1. The Division will install a sprinkling system and seed to grass the median area, and enlarge Desert Vista Park areas, at no cost to the City.
2. The Division will reimburse the City Water Department for actual expenses incurred in making one 4" water tap necessary for aforementioned sprinkling system, in an amount not to exceed \$600.00.
3. The Division will install two ornamental light standards at the intersection of S.H. 70 and Main Street, at no cost to the City.
4. Upon completion of items mentioned in paragraphs 1. and 2., the City will maintain the areas landscaped, with its forces, and furnish all water required, both at no cost or obligation to Division.
5. Upon installation of the two ornamental lights by the Public Service Company, the City will assume all costs necessary to the continued operation and maintenance thereof.

6. This agreement shall be binding upon and inure to the benefit of the successors and assigns of parties hereto, respectively.
7. This agreement shall not be deemed valid until it shall have been approved by the Controller of the State of Colorado, or by such assistant as he may designate.

IN WITNESS WHEREOF, the parties hereto have caused the foregoing Agreement to be executed the day and year first above written.
