Recitals.

On the 16th day of December, 1993, the Community Development Director filed with the City Clerk of the City of Grand Junction, Colorado, a request that the City Council of the City of Grand Junction commence proceedings to annex to the City of Grand Junction a certain tract of land located in the County of Mesa, State of Colorado, commonly known as the Climax Mill Site, and more particularly described as follows:

That the ordinance annexing the subject area is scheduled for introduction and first reading on the 16th day of February, 1994 with second reading of the proposed annexation ordinance on March 2, 1994.

CLIMAX MILL ENCLAVE ANNEX:
