

RESOLUTION NO. 108-94

A RESOLUTION AMENDING THE SOLID WASTE MANAGEMENT FEES.

RECITALS.

WHEREAS, the increase in the commercial and residential rates are required as a result of annual cost increase in goods and supplies to provide solid waste service.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION THAT THE FOLLOWING SOLID WASTE FEES BE IN EFFECTION JANUARY 1, 1995:

(1) RESIDENTIAL RATE. The following rate shall apply for all residential uses:

(a) Single-family dwellings: Nine dollars and ten cents (\$9.10) per month for weekly collection of all refuse.

(b) Double or multifamily dwellings:

2 units.....	\$14.57
3 units.....	20.12
4 units.....	25.66
5 units.....	31.29
6 units.....	36.84
7 units.....	42.37
8 units.....	47.90

(c) Senior citizen rate: A reduction of one dollar (\$1.00) per month from the basic minimum rate.

(d) Residential recycling rate: One dollar and fifty cents (\$1.50) per month for monthly collection of recyclables.

(2) COMMERCIAL RATE:

(a) The minimum charge shall be twelve dollars and ninety-six cents (\$12.96) per month for weekly collection of up to five (5) thirty-five-gallon containers shall be:

Once a week service.....	\$12.96
Twice a week service.....	22.44
Three times a week service.....	32.08
Four times a week service.....	41.65
Five times a week service.....	51.29
Six times a week service.....	60.90

(b) The monthly rental and service charge for the collection of dumpsters shall be as follows:

(3) INDUSTRIAL RATE. All industrial users shall be charged the industrial rate.

(a) The minimum charge shall be twenty five dollars and forty nine cents (\$25.49) per month for weekly collection of up to one hundred seventy-five (175) gallons of refuse not to exceed a total of two hundred fifty (250) pounds in weight.

(b) Additional service by frequency or volume may be provided an industrial user on a cost basis.
