REPORTS

Rate Structure Options and Revenue Presentation - AMEC

- Aaron Murray gave a presentation concerning the Rate Structure.
- There were questions, answers, and discussions during the presentation.
- The rate structure consists of at least three options, being a flat rate (same rate for all residential properties), tiered rate (with at least three tiers), and actual impervious (measuring each property for impervious area).
- The recommended option by AMEC is the Impervious Area Rate Structure (single family residential 3 tiers; non-single family residential measure actual impervious area).
- Jon Sorenson gave a Revenue presentation.
- AMEC will send copies of the revenue presentation to the Board and Staff, as they were not available at the time of the presentation.
- Flat fee was not recommended. It looks more like a tax than a utility fee for service.
- The *utility fee* was recommended to be billed *to owner* of the property.
- Churches and schools are to be billed. They can be put in a separate category and charged a lower fee and given credits if they are MS4 permittee's.
- Credits might be 3-5% of collected revenue.
- Credits can be given for incentives such as more landscaping, gravel driveways, anything that eliminates/reduces impervious areas according to criteria established by the 5-2-1 Drainage Authority before any bills are sent out.
- Agriculture is typically exempt.
- Jon Sorenson gave examples of towns throughout Colorado and the utility *fee* they choose and some of the background supporting reasons.
- AMEC suggested a Citizens Committee or Taskforce be created to have a voice in the process and presenting it to the public. The committee should represent all phases of the community; car dealers, farmers, churches, schools, elderly, families, businesses, etc.
- Be able to tell the public what the *utility fee* will provide for them.

- There will need to be a *Level of Appeal* for the *utility fee* process.
- Dave Karisny asked what the next step should be.
- Jon Sorenson responded that the Board should finish the discussion on the O & M White Paper and adopt the O & M resolution before they proceed with the Rate Study.
