RESOLUTION NO. 09-00

A RESOLUTION DETERMINING THE NECESSITY OF AND AUTHORIZING THE ACQUISITION OF CERTAIN PROPERTY BY CONDEMNATION FOR IMPROVEMENTS TO AND NEW PORTIONS OF 27.5 ROAD AND ITS INTERSECTION WITH HORIZON DRIVE AND G ROAD AND OTHER MUNICIPAL PUBLIC FACILITIES

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

<u>Section 1</u>. It is hereby determined that it is necessary to the public health, safety and welfare that the property described below ("Property") be acquired for right-of-way, street, sidewalk, utility, drainage and other public improvement purposes. The Property is to be acquired by negotiation and purchase if possible; provided, however, the condemnation of the Property is hereby specifically approved and authorized. The property sought to be acquired is to be used for municipal public purposes.

<u>Section 2</u>. The City Attorney is hereby specifically authorized and directed to take all necessary legal measures, including condemnation, to acquire the Property which is hereby determined to be necessary to be acquired to be used for right-of-way, street, sidewalk, utility, drainage and other public improvement purposes. The City Attorney is further authorized to request immediate possession of the Property.
