The canvassing board met on November 18, 2003 and reviewed the returns and has certified that 13,898 city voters participated in the election. The issue passed 72% to 27%. The voter breakdown was 10,009 in favor, 3,702 against, 3 voted yes and no and 184 left it blank.
