ALTERNATE HEARING OFFICER SAM STARRITT

I. CALL TO ORDER

The meeting was called to order at 2:01 p.m. Those present were Hearing Officer Sam Starritt, City Attorney John Shaver, and Deputy City Clerk Debbie Kemp.

II. OTHER BUSINESS

1. Review Boomers, LLC dba Boomers, 436 Main Street, Grand Junction, CO 81501, Tavern – Review Status

Chester Allen, owner of Boomers, was present. He advised the Authority that the prospective owners are still working on putting together their LLC. They have additional investors that want to be part of the LLC.

Ms. Kemp advised that she had a phone conversation with one of the prospective owners, Mr. Mark Coffman, and he advised that they are still working out the details of the ownership of the LLC and he requested a month continuance for this item. Ms. Kemp reminded him that at the March 19, 2014 Liquor and Beer meeting, Hearing Officer Grattan gave them a drop dead date for having the transfer of ownership filed with the City Clerk's Office of May 7, 2014.

City Attorney Shaver recommended that the review be continued once again for two weeks to get an update on the status and notify the prospective owners.

Hearing Officer Starritt agreed and asked Ms. Kemp to make sure that the prospective owners are aware of the date and time of the next review.

III. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

1. Bank 8 Billiards, Inc. dba Bank 8 Billiards, 2460 Patterson, Unit #3, Grand Junction, CO 81505, Tavern

No one was present representing the applicant.

Ms. Kemp reported that there were two incidents reported by the Police Department at the establishment, however, no administrative action has been taken for the establishment.

Hearing Officer Starritt noted that there was no one present in opposition of the renewal.

The application for renewal for Bank 8 Billiards, Inc. dba Bank 8 Billiards was found to be in order and approved.

2. Fantasy, LLC dba Fantasy, 2258 Colex Drive, Grand Junction, CO 81505, Tavern

No one was present representing the applicant.

Ms. Kemp noted that there were several violations reported by the Police Department regarding a variety of incidents at the establishment and the City Attorney's office is conducting an administrative review for an incident which occurred at the establishment. Ms. Kemp also advised that there were several incidents involving the owner, Kevin Eardley, reported by the Police Department.

Hearing Officer Starritt asked what the incidents were against the owner. Ms. Kemp advised that Mr. Eardley is a primary subject of a homicide/burglary investigation with the Mesa County Sherriff's Office, he was cited for loud music and loud yelling on public and private property, he was cited for disorderly house for loud music still playing at 7:00 a.m. in the morning and alcohol was strewn all over the inside and outside of the residence, there was report of a 20 year old female being drugged and sexually assaulted at Mr. Eardley's residence during a party, and Mr. Eardley was the subject of a criminal mischief case involving his neighbor's property being destroyed. The damage occurred after Mr. Eardley received the above disorderly house citation.

Hearing Officer Starritt asked what the nature of the administrative review is. Ms. Kemp stated that she does not know, however, DeLayne Merritt or Meghan Woodland could possibly answer that. City Attorney Shaver advised that Ms. Merritt is the Staff's Prosecuting Attorney with the City Attorney's office, and they keep a separation with each other for these types of issues. Her representation will be from the enforcement side. Ms. Merritt advised that the administrative review is for a DUI incident that occurred on March 9, 2014 concerning an over-service and determining whether or not an administrative citation will be issued to the licensee for that.

City Attorney Shaver advised that if an administrative citation is issued, it will be handled through a separate proceeding. This is just to inform the Authority that this is pending and may be brought back. City Attorney Shaver advised that the Authority could continue this matter and run it concurrently with the administrative proceeding, or could approve the renewal with the understanding that it may come back separately as an administrative proceeding which could result in a suspension or revocation.

Hearing Officer Starritt noted that there was no one present in opposition of the renewal.

The application for renewal for Fantasy, LLC dba Fantasy was found to be in order and approved noting that, if it comes back with an administrative proceeding, it may have some effect on the license. Hearing Officer Starritt expressed concern for the violations noted for the business as well as Mr. Eardley's personal violations.

3. The Grand Inn, LLLP dba Holiday Inn Hotel and Suites Grand Junction, 2751 Crossroads Boulevard, Grand Junction, CO 81506, Hotel and Restaurant

No one was present representing the applicant.

Hearing Officer Starritt noted that there was no one present in opposition of the renewal.

The application for renewal for The Grand Inn, LLLP dba Holiday Inn Hotel and Suites Grand Junction was found to be in order and approved.

4. Carson, Inc., dba Johnny's Beer and Liquor, 2648 Patterson Road, Grand Junction, CO 81506, Retail Liquor Store

No one was present representing the applicant.

Hearing Officer Starritt noted that there was no one present in opposition of the renewal.

The application for renewal for Carson, Inc., dba Johnny's Beer and Liquor was found to be in order and approved.

1. Colorado Mesa University Foundation, 1450 N. 12th Street, Grand Junction, CO 81501 – Football Legends Dinner on May 2, 2014 from 5:00 p.m. to 11:00 p.m., 1100 North Avenue, Grand Junction, CO 81501, Malt, Vinous, and Spirituous

Pres./Sec'y. of Org.: Peggy Lamm, 1450 N. 12th St., Grand Junction, CO 81501

Event Manager: Rick Adleman, 1450 N. 12th St., Grand Junction, CO 81501

Gail Howe, program coordinator for Colorado Mesa University Foundation, was present.

City Attorney Shaver handed Ms. Howe two documents marked A and B and asked her if she has personal knowledge in the document marked A. Ms. Howe said she does because she completed the document. City Attorney Shaver asked Ms. Howe to describe what they are applying for. Ms. Howe said the football alumni chapter of the Colorado Mesa University Foundation will be having a fundraiser dinner at the Maverick Pavilion on campus which is a self-contained building. City Attorney Shaver asked how many attendees are

expected. Ms. Howe said about 250 people at the most. City Attorney Shaver asked if Colorado Mesa University has sponsored the same or similar events in the past. Ms. Howe said that they have, not with this event, but with similar events. City Attorney Shaver asked if, through prior events, have experience with the provisions of service of alcoholic beverages. Ms. Howe said yes. City Attorney Shaver asked Ms. Howe to describe how they will ensure persons are of lawful age to consume alcohol. Ms. Howe said that they are hiring three security officers with Citadel Security & Investigations (CSI) for the event and will have two tables in the foyer area before the entrance to the event where identification will be checked and they will be wrist banded at that time. City Attorney Shaver asked if anyone under the age of 21 will be allowed. Ms. Howe said no. City Attorney Shaver asked Ms. Howe if she has knowledge of the document marked with a B, the diagram, and asked her to describe the diagram. Ms. Howe said she does because she went to the building on campus and drew out the diagram. She said that the diagram shows the front area, the foyer area, where people will enter and then go into an enclosed area where the event will be held where there will be food (a full dinner), beer and wine served, and a silent auction. City Attorney Shaver asked what the series of red dots indicate. Ms. Howe said that is the enclosed area and there will be no alcohol outside that area. City Attorney Shaver asked how that will be maintained. Ms. Howe said there will be security at the exits as well as the entrance. City Attorney Shaver asked Ms. Howe if it her desire that the special events permit be issued. Ms. Howe said yes.

Hearing Officer Starritt asked about the Maverick building and if it is the Colorado Mesa University ballroom. Ms. Howe said no, it is a free standing building which is white tented and used for athletics.

Hearing Officer Starritt admitted Exhibits A and B into the record (see attached) and found the application for a special events permit for Colorado Mesa University Foundation was in order and approved as the issuance of the permit would not be injurious to the public welfare by reason of the nature of the special event, its location within the community, or the failure of the applicant in past events to conduct the event in compliance with applicable laws and regulations.

2. Center for Independence, Inc., 740 Gunnison Avenue, Grand Junction, CO 81501 – Dine in the Blind on April 12, 2014 from 12:00 p.m. to 10:00 p.m., 740 Gunnison Avenue, Grand Junction, CO 81501, Malt, Vinous, and Spirituous

Tami Walter, Executive Assistant for the Center of Independence and Event Manager for Dine in the Blind, was present.

City Attorney Shaver handed Ms. Walter two documents marked A and B and asked her if she has personal knowledge of the documents. Ms. Walter said

she did because she prepared the application. City Attorney Shaver asked Ms. Walter to describe what the Center for Independence is and what she does for them. Ms. Walter stated that it is a center for independent living and they help disabled individuals get back on their feet and learn how to live independently. City Attorney Shaver asked if the event is scheduled at their location of 740 Gunnison Avenue, Grand Junction, CO. Ms. Walter said yes. City Attorney Shaver asked Ms. Walter to describe for the Authority what the event is. Ms. Walter said it is a fundraiser for the low vision and senior blind program. As guests arrive, they are blindfolded and proceed through their dinner blindfolded so they can experience dinner as a person without sight. They are told where their food is on the plate such as six o'clock, nine o'clock, etc. After dinner, they are de-masked and there is a live auction, music, and dancing. City Attorney Shaver asked if this event or similar events have been held in the past and have there been any problems. Ms. Walter said this event has been held in the past and there have not been any problems. City Attorney Shaver asked how many people are expected at the event. Ms. Walter said that they expect roughly 200 and there is room for 206 people. City Attorney Shaver asked how the service of alcohol will be done in accordance to the law. Ms. Walter stated that everyone will be carded at the door when entering. Anyone under 21 years of age will be stamped. Everyone will be asked again for their identification at the bar. Ms. Walter has been TIPS trained and will be bartending. There will be three security staff that have worked security in the past. City Attorney Shaver asked how many people will be working the event. Ms. Walter said there will be about 15 staff members and about 20 volunteers. City Attorney Shaver asked Ms. Walter to describe Exhibit B. Ms. Walter said that outlined in red is their gymnasium which shows the table set up and the chair placement. It shows the entry door where people will check in and have their identifications checked and they will then be led into the gymnasium. City Attorney Shaver asked what perimeters they will have in place to insure that the alcoholic beverages will not leave the gymnasium. Ms. Walter said that there will be security at the exit and the ramp area to the smoking area throughout the evening to make sure no one leaves the gymnasium with alcohol. City Attorney Shaver asked Ms. Walter if it is her desire that the special events permit be issued. Ms. Walter said yes.

Hearing Officer Starritt asked about the duties of the staff versus the duties of the volunteers. Ms. Walter said that the staff will be handling the security and the identification and the volunteers will be seating and helping the people.

Hearing Officer Starritt admitted Exhibits A and B into the record (see attached) and found the application for a special events permit for Center for Independence, Inc. was in order and approved as the issuance of the permit would not be injurious to the public welfare by reason of the nature of the special event, its location within the community, or the failure of the applicant in past events to conduct the event in compliance with applicable laws and regulations.

Shawnalee Demers, President and Parent Council for the school and Event Manager for the Juniper Ridge Gala, was present.

City Attorney Shaver handed Ms. Demers two documents marked A and B and asked her if she has personal knowledge of the document marked A. Ms. Demers said she did because she prepared the application. City Attorney Shaver asked whose signature was on document A. Ms. Demers said it is her signature. City Attorney Shaver asked if the information on Document A, the questionnaire and affidavit, was true and correct. Ms. Demers said yes. City Attorney Shaver asked Ms. Demers to describe the event and what they expect to get from the event. Ms. Demers said it is the first year for the school and this is the first event they are doing. It is a silent auction and gala, some music and dancing, and some fun. They hope to bring in a lot of money for the school. City Attorney Shaver asked if they have an estimate of how many people will attend. Ms. Demers said they are hoping for 100 people. City Attorney Shaver asked how the service of alcohol will be conducted in accordance to the law. Ms. Demers said that they have hired Fisher’s Liquor Barn and two of their employees will be manning the bar. There will be a professional armed security officer from Junction Security at the door and three of their volunteers will be greeters to be sure everyone’s identification is checked at the door. There will be no one under the age of 21 years old allowed in. The drinks will not be allowed outside of the room. People will be stamped when leaving the room to go to the restroom so that they can get back in. City Attorney Shaver asked if there was a maximum occupancy for the room. Ms. Demers said she believed it was 200. City Attorney Shaver asked who will be in charge to make sure the attendance does not exceed maximum occupancy. Ms. Demers said it will be the security officer, herself, and the other person listed on the special events permit application. City Attorney Shaver asked Ms. Demers to describe for the Authority what is shown on Exhibit B. Ms. Demers said that it is a drawing she drew herself. It shows the stairs going into the building from Main Street. At the top of the stairs is the main ballroom where they will be. To the right of the ballroom will be tables with food. There are other rooms that will be locked for the most part unless the tenants open them and bathrooms down the hall. City Attorney Shaver asked how they will make sure that alcohol is not taken out or brought into the ballroom. Ms. Demers stated that the greeters and the security officer will be at the door to the entrance. City Attorney Shaver asked if that will be the only ingress/egress to the event. Ms. Demers confirmed that to be true. City Attorney Shaver asked if the only area for alcohol service will be the ballroom area. Ms. Demers replied affirmatively. City Attorney Shaver asked

Ms. Demers if it is her desire that the special events permit be issued. Ms. Demers said yes.

Hearing Officer Starritt asked for more clarification on the diagram as to what is being requested to be the licensed premises. Ms. Demers said it will be the 60' x 45' ballroom and the 20' x 30' room to the right of the ballroom.

Hearing Officer Starritt admitted Exhibits A and B (which was amended to indicate the licensed premises in dashed blue ink) into the record (see attached) and found the application for a special events permit for Juniper Ridge Community School was in order and approved as the issuance of the permit would not be injurious to the public welfare by reason of the nature of the special event, its location within the community, or the failure of the applicant in past events to conduct the event in compliance with applicable laws and regulations.

4. Colorado Plateau Mountain Bike Trail Association, Inc., P.O. Box 4602, Grand Junction, CO 81502, MOG Outdoor Fest & COPMOBA Bike/Gear Swap on April 19, 2014 from 10:00 a.m. to 9:00 p.m., the area on 4th Street from Rood Avenue to Main and from 4th Street to 5th Street on Main Street, Grand Junction, Malt and Vinous

Jen Taylor Muhr, Event Manager, was present.

City Attorney Shaver handed Ms. Taylor Muhr two documents marked A and B and asked her if she has personal knowledge of the documents. Ms. Taylor Muhr said she did because she authored document A and printed the diagram from the City's GIS site and drew the outline on document B. City Attorney Shaver asked how many years the event has been held. Ms. Taylor Muhr said that this is the 11th year for the event, but only the 3rd year that they have applied for a liquor permit. City Attorney Shaver asked if there have ever been any problems during the event. Ms. Taylor Muhr said there has not. City Attorney Shaver asked about the perimeter outlined in red on document B. Ms. Taylor Muhr said that it shows the MOG sale and the COPMOBA bike and gear swap. It will be on 4th Street from Rood Avenue to Main Street and on Main Street from 4th Street to 5th Street. City Attorney Shaver asked if the entire area will be licensed with the point of sale as indicated in blue. Ms. Taylor Muhr said yes. City Attorney Shaver asked Ms. Taylor Muhr to describe for the Authority how the service of alcohol will be conducted in accordance to the law. Ms. Taylor Muhr said that Rockslide's trained staff will facilitate the sale of the beer and the identification process. City Attorney Shaver asked if Ms. Taylor Muhr has given Rockslide any specific direction on the identification process. Ms. Taylor Muhr said she will make sure that all persons of legal age to drink alcohol will be wrist banded. City Attorney Shaver asked how many people are

expected at the event. Ms. Taylor Muhr said the admission is free so it could be anywhere from 1,500 people to 3,000 people and possibly more. City Attorney Shaver asked Ms. Taylor Muhr how the perimeter will be maintained. Ms. Taylor Muhr said the three street access points will be closed by Your Way Sign Company. Outside areas will be blocked off with yellow construction tape and barriers provided by the City. The alleyway to the parking garage, the DDA parking lot, and the alley points on 4th Street will be taped off and have a security person watching the areas. City Attorney Shaver asked Ms. Taylor Muhr if it is the same general area as the events in the past. Ms. Taylor Muhr said it is not, it is a new area. City Attorney Shaver asked if the security is paid security. Ms. Taylor Muhr said yes, as well as trained volunteers. City Attorney Shaver asked Ms. Taylor Muhr if it is her desire that the special events permit be issued. Ms. Taylor Muhr said yes.

Hearing Officer Starritt asked for more clarification on the road closures. He asked if the perimeters will be fenced off. Ms. Taylor Muhr said that the buildings will provide some of the barriers but barricades and tape will be used for the other areas. Hearing Officer Starritt asked if that was some type of other process they have to go through in order to have the roads closed off. Ms. Taylor Muhr said that she contracts with Your Way and showed Hearing Officer Starritt a road closure map. City Attorney Shaver advised that there is another application process for the road closures with the City.

Hearing Officer Starritt admitted Exhibits A and B into the record (see attached) and found the application for a special events permit for Colorado Plateau Mountain Bike Trail Association, Inc. was in order and approved as the issuance of the permit would not be injurious to the public welfare by reason of the nature of the special event, its location within the community, or the failure of the applicant in past events to conduct the event in compliance with applicable laws and regulations.

V. OTHER BUSINESS

Ms. Kemp advised that there is still one unpaid Occupational Tax License for A Taste of Heaven Catering and asked City Attorney Shaver if she could send it up to his office so a letter could be sent to the establishment. City Attorney Shaver said yes and noted that he had left several messages with the owner of the establishment.

VI. ADJOURNMENT
