- 1. 7:30 p.m. Introduction.
- a.) Announcements:

Pat Kennedy announced the date and time for the upcoming Urban Trails committee Retreat. b.) Urban Trail Plan Presentation - 11/25/97 Mesa County Commissioners Meeting

Pat informed the Committee of the date change from 10/14/97 to 11/25/97, 9:00 a.m. He reviewed the issues addressed at the Mesa County Planning Commission meeting held on 9/25/97. The Urban Trails Plan was adopted by the Planning Commission with very few exceptions. One change in particular addressed the trails map and a request to designate the canal areas in red, therefore delineated them as "No Public Access."

Jack Scott discussed City Council's recent meeting with the Canal Authorities. He stated his support for the Urban Trails Committee in acquiring access for public trails on necessary canal banks.

Pat concluded the discussion with a reference to a list of names and addresses of the land owners adjacent to the canal banks. He said there is consideration of a letter to these folks that attempt to address concerns and outline the Urban Trails Committee's intentions for the proposed use of canal banks as part of the overall trail system.

Other Committee members discussed a need to publicly identify those particular canal banks targeted for public access. There was consensus that once these proposed accesses are identified and relayed to the public, it may alleviate some landowners concerns that do not own property along the canals in question.
