

Grand Junction Colorado April 12th 1886

Minutes of a regular meeting of the Board of Trustees of the Town of Grand Junction Colorado, held at the Council Room on Monday Evening April 12th 1886.

Meeting called to order at 7³⁰ o'clock P.M. by Mayor James W. Bucklin

On roll call

Minutes of the last meeting of April 8th 1886 were read and approved.

The committee appointed at last meeting to solicit propositions for water reported that they had not been able to get a satisfactory proposition and the Committee was on motion discharged.

The following bills against the Town were then read and on motion allowed and warrants ordered drawn for the respective amounts, to wit:

Price and Kingsley for Printing as per itemized bill \$ 6.37

O'Donnell & Hollahan for board of Prisoners 17.70

J. A. Barrett Services as Marshall 12 days April 10th to 12th at 75⁰⁰ per month 30.00

On motion the Salary of the Marshall was fixed at \$75⁰⁰ per month

It was then moved seconded and carried that the Board do now proceed to appoint one of their members Mayor Pro Tem Carried and the Board proceeded to ballot for Mayor pro tem. those who voted were

W. J. Carpenter received five (5) votes and D. S. Dickey One vote, and W. J. Carpenter have received the required number of votes was declared duly appointed Mayor Pro tem.

On motion the Board then proceeded to ballot for Marshall.

Three ballots having been taken and no candidate having received a majority, a fourth ballot was taken with the following result

Lorin A. Staley was elected town attorney.

W. A. Marsh was elected town treasurer.

A. J. McCune was elected town engineer.

W. A. Rice was elected police magistrate.

John Hynes and J. T. Sharp were appointed a committee to obtain price of printing for ensuing year.

The mayor then appointed the following standing committees.

FINANCE: Hynes, Dickie, Sharp.

STREETS, ALLEYS AND BRIDGES:

Price, Sharp, Hynes.

LICENSES: Dickie, Carpenter and

Hynes.

WATER: Sharp, Carpenter, Price.

Adjourned to April 13th, 1888.

APRIL 13, '88.—Mr. D. P. Kingsley

was elected town printer for the ensuing year.

Bonds of marshal, treasurer, recorder etc. approved.

John MacArthur and George M. Huskins were appointed a committee to examine books of outgoing treasurer.
