January 13th A.D. 1892

City Council met in regular session. Present: Mayor L. M. Miller Aldermen M. L. Allison, R. C. Bower, E. W. Lannon, W. H. Lee, J. S. Hall, L. W. Voss's Sec. Ryan and D. P. Stetzelberger

Minutes of Regular meeting held Dec. 8th at 9.0 clock A. M. minutes of adjourned meeting held Dec. 8th at 7.0 clock P. M. minutes of adjourned meeting held Dec. 15th and minutes of called meeting held Dec. 23<sup>d</sup> A.D. 1891 were all read and approved

A petition for side-walk along block 51 on Gunnison Ave. was read and on motion referred to Com. on Streets & Alleys

A petition for an Arch light, <sup>at corner of 5<sup>th</sup> & Pittsburgh Ave</sup> signed by Sev. Wheeler et al, was read and on motion referred to com. on lights

Reports of City Treasurer and City Marshal for Dec. were read and on motion referred to Finance committee

Grand Junction Water Co. presented bill for \$1775.<sup>00</sup> D. P. Stetzelberger from the Finance com. made a <sup>minority</sup> report and recommended that the Council pay \$1591.<sup>43</sup> and made a motion to that effect, M. L. Allison made a motion as an amendment, that the bill lay over until a test of the Water works had been made, the amendment carried

Report of Byres Chief of Fire Department, was taken up and on motion adopted, A communication from Salt Lake Plain <sup>on the subject of carrying petition</sup> was ~~read~~ read, a committee of three consisting of M. L. Allison, D. P. Stetzelberger and J. S. Hall were appointed to draft proper resolutions regarding the same.

The subject of a contract with the Electric Light Co. was discussed and the Mayor referred the same, to the Committee on Lights & Water, to make a contract, and present it to the Council for their approval.

Bill of D. K. Crosby for \$300.<sup>00</sup> and bill of R. J. McCune for \$113.<sup>00</sup> were read and on motion referred to the Finance Committee
