Nov. October 14 A. D. 1893

City Council met in regular session. Present Mayor M. L. Allison, Aldermen J. B. Hall, W. S. Wallare, J. H. Cosgrove, M. J. Devereux, W. S. Wallare, and J. J. McQuillan. Minutes of Regular meeting held October 10th A. D. 1893 and minutes of special meeting held October 10th A. D. 1893 were read and approved. Reports of City Treasurer, City Marshal, Police Magistrate, and City Mayor for month of October A. D. 1893 were read and referred to the Finance Com. Finance Com. reported that they had examined the reports of the City Treasurer and City Mayor for month of Sept. and found same correct on motion the report was adopted. The Finance Com. further reported that they had examined the reports of City Marshal and Police Magistrate for month of Sept. 1893 and that the same did not agree. On motion the two latter reports were referred back to the Finance Com. for further examination. Charges preferred by Daniel Mullen vs J. A. Ketchum City Marshal were read. On motion the charges were lain on the table. Abstract of votes cast at a special election held October 16th A. D. 1893 for purpose of granting franchise to Colorado Western Development Com. Abstracts of votes shown that 136 votes were cast for franchise and 4 votes against franchise.

24 votes for - 4 against

The following resolution was read and adopted
Whereas, A clerical error was made in certifying the sidewalk tax on lots 21 & 22 in block 104 as heretofore made and the same was certified against lots 20 & 21 instead of 21 & 22. The clerk is therefore hereby instructed and directed to certify such correction at once to the proper officers as provided by law. On motion the City Clerk was instructed to draw a warrant of \$2.50 for each of the Judges and clerks of the special City election held October 16th 1893.
