
Memorandum of Understanding



Hoak Media of Colorado, LLC dba KREX/KREY/KREG/KGJT

and

The City of Grand Junction ("City or "The City")

This Memorandum of Understanding (MOU) sets forth the terms and understanding between The City and KREX/KREY/KREG/KGJT for the installation of microwave radio equipment at Suplizio Field / Stocker Stadium.

Background

KGJT is planning on carrying local sports ("games") that are played at Suplizio Field / Stocker Stadium. The installation of a microwave link will enable KGJT to televise games over broadcast, cable, and satellite to the local area. The microwave link would be capable of sending a digital video feed to the KGJT studios utilizing an antenna mounted on the roof of the Lincoln Park Tower (1307 North Avenue). See attachment

Purpose

This MOU will grant KREX/KREY/KREG/KGJT the privilege of mounting a microwave antenna to establish a digital link to their studios for the purpose of carrying locally produced video back to the studios for broadcast.

The City will allow KREX/KREY/KREG/KGJT to mount the antenna on the roof of the Lincoln Park Tower on the exterior of the North stairwell entrance. All reasonable steps will be taken to preserve water penetration to the building from the mounting of any equipment. The City will allow KREX/KREY/KREG/KGJT to install wiring to said antenna from the associated press box for connection to the KREX/KREY/KREG/KGJT video production equipment.

Access

Access to the facilities for KREX/KREY/KREG/KGJT will be coordinated with The City by and through staff and authorized personnel who is and for this agreement designated as the Stadium Supervisor. Non-game day access will be provided during normal business hours with a minimum 24 hours notice of need to access areas where equipment is installed

Liability

The City allows KREX/KREY/KREG/KGJT to install any necessary equipment without warranty or liability. Hoak Media releases the City and its officers and employees for any and all damages, liability, and injury to persons or property that arise out of or are claimed to arise out of

or under this agreement and/or any actions that are taken in furtherance of the agreement/rights conferred thereunder.

Duration


This MOU is at-will and may be modified by mutual consent of authorized officials from The City and KREX/KREY/KREG/KGJT. This MOU shall become effective upon signature by the authorized officials from The City and KREX and will remain in effect until modified or terminated by any one of the partners by mutual consent.

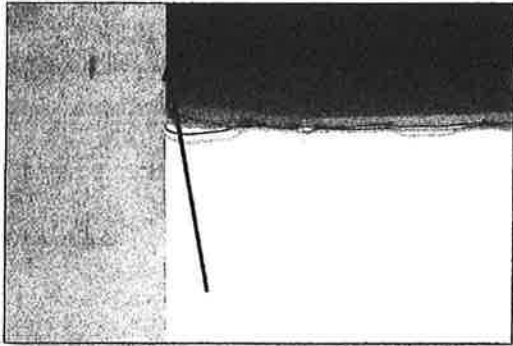

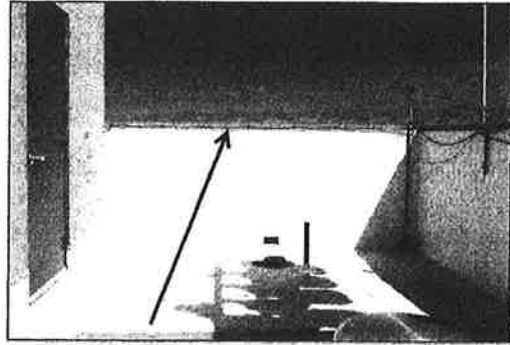

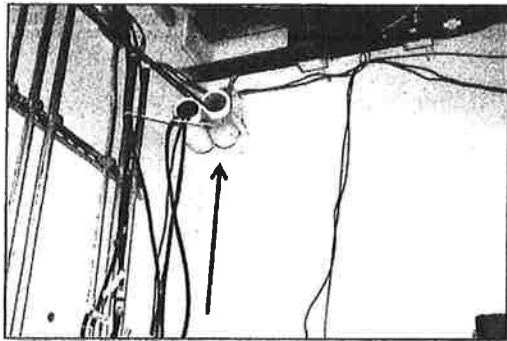

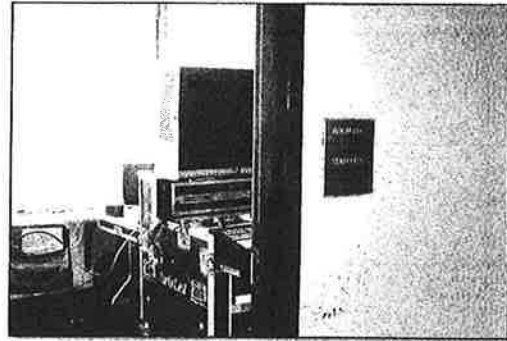
Antenna Location
