Adjourn meeting of city council Mayor Echa in chair upon roll call the following alderman responded Levy. Bronner. Dickerson McKimney. Starr. Smith. Ramey and Whorton

Minutes of June 13. 14 and 23 read and approved with corrections The Bill No 134. Rodgers & Shafroth which was for \$750.00 and city clerk had drawn a warrant for \$350.00 under minutes of June 13 1899 was made \$600.00 and Clerk instructed to draw warrant for \$600.00 in favor of Rodgers & Shafroth City clerk read a letter from Rodgers & Shafroth concerning their bills against the city
