Roll Call

The City Council of the City of Grand Junction convened, at a regular adjourned session, Mayor Bunting presiding, upon call of roll the following responded present Alderman Davies, Lutes, Mc Culloch, Norris, Boyle and City Atty N. E. Coles, Alderman Smith & Platt arrived a few minutes late, Alderman Alker absent.

Minutes

The minutes of previous meeting were read corrected and approved as corrected.

Ernest Adams Jr.

request the people to smudge in case of frost

Ernest Adams Jr. was present and made a verbal request of the City Council for them to notify the public that there would be a car load of oil here in a few days to be distributed throughout the valley for smudging purposes in order to protect the fruit in case of frost, thereupon Alderman Smith made a motion seconded by Alderman Lutes that the request of Mr. Adams be granted and to authorize for publication a notice in the daily papers requesting the citizens to join with the officials in smudging in case of a frost whenever an alarm is sounded to that effect upon call of motion said motion carried unanimously.

Petition for a cement crossing on White & 10th

The petition of J. D. Vaughan and others for a cement crossing to be laid on the south side of White Street crossing tenth street was read, and referred to the street and alley committee.

W. R. Agard

The petition of W. R. Agard for the position of City Park tender was read and referred to the street and alley committee.

Mine & Timber

Supply Co allowed to cross lower 7th street with R.R. spur.

The street & alley committee reported favorable upon the petition of The Mine & Timber Supply Co. by F. E. Gowan manager to cross lower 7th street with a Railroad spur on the north side of track running to Sugar Factory, thereupon Alderman Norris made a motion seconded by Alderman Smith that the report of committee be accepted and ratified upon call of motion said motion carried unanimously.

Sarah McLean

petition not granted.

The Fire & Police committee reported unfavorable upon the petition of Sarah McLean to erect a wooden coal shed upon the rear of lot 25 block 119, thereupon Alderman Davies made a motion seconded by Alderman Mc Culloch that the report of committee be accepted and ratified upon call of motion said motion carried unanimously.

Petition for
2" Water main
in Carpenters
Sub. Granted.

The petition of E. E. Junck and seven other water users living in Carpenters Sub. division for a 2 Inch water main to be laid instead of the $\frac{3}{4}$ Inch now in use was reported upon as favorable by the Water & Sewers Committee thereupon Alderman Boyle made a motion seconded by Alderman Platt that the report of Committee be accepted and affirmed upon Call of motion said motion carried unanimously.

Crawford add.
to have road
opened up
between Lawrence
ave & Colo ave

The petition of the Citizens living in Crawford addition to have its street opened up across the RR. track was discussed pro and con, and it was found impracticable. Attorney Leaverton in behalf of the Citizens living in Crawford add. presented ~~the~~ ^a plan ^{verbally} to have the City buy the triangular piece of property in front of George Harsh's property which would open up River view ave. and thence open a road along the Railroad running ^{north} ~~west~~ to Colorado Avenue which could be done at a nominal cost. thereupon Alderman Norris made a motion seconded by Alderman Boyle that the street and Alley Committee be appointed to investigate said proposition with full power to act upon Call of motion said motion carried unanimously.

Beet Pulp
to be hauled
up 7th Street.

A Communication was read from the Chamber of Commerce asking that the City Council request the management of the Sugar Factory to instruct their patrons not to haul the Beet pulp through the business streets of the City on account of the offensiveness of the odor. thereupon Alderman ~~Futer~~ ^{Davis} made a motion seconded by Alderman M^c Calloch that the Health Officer notify the Manager of the Sugar Factory to instruct his patrons not to haul their Beet pulp upon or through the business streets of this City other than 7th Street, upon Call of motion said motion carried unanimously.

Posts to be
removed from
near the
Abbey Saloon

Fire Chief Rogers entered a Complaint about the hitching post near the Abbey Saloon saying that they were dangerous to the Fire Department in case they were making a run to a fire, and teams being hitched thereto they blocked up the roadway. thereupon Alderman Futer made a motion seconded by Alderman Davis that the Street Supervisor be instructed to remove the said posts, upon Call of motion said motion carried unanimously.

Keep empty
vehicles off
streets

Alderman Davies made a complaint in regard to the blockading of streets with ~~the~~ empty Wagons and Vehicles on south 5th Street between Pitkin + Colovar and on Colovar between 3rd + 6th Street the City Marshal was instructed to notify the parties obstructing the streets to keep their vehicles in close to the curb line.

Alderman Boyle made a motion seconded by Alderman Platt to go into executive session upon call of motion said motion carried unanimously.

Alderman Smith made a motion seconded by Alderman Platt to return to regular order of business upon call of motion said motion carried unanimously.
