Grand Junction Colo. Nov. 8th a.D. 1906

The City Council of the City of Grand Junction convened in special session, Mayor Bunting presiding, upon call of roll the following responded present Alderman Alkire, Davies, Lutes, McCulloch, Norris, O'Boyle, Platt and Smith.

The following Tax levy resolution was introduced by Alderman Davies.

Be it resolved by the City Council of the City of Grand Junction, Colorado, that for the purpose of defraying the expenses and liabilities of the City of Grand Junction, Colorado, for the fiscal year beginning April 1st a.D. 1907 and ending March 31st a.D. 1908, there be and hereby is levied and assessed upon all the taxable property within the corporate limits of said City of Grand Junction, both real and personal, the following amounts for special and general taxes, namely;

First -- For the purpose of defraying the annual interest on water works bonds, issued in the years 1897 and 1899, a special tax of three and one half mills ($3\frac{1}{2}$) on each dollar of said property so assessed or to be assessed,

Second -- For the purpose of defraying the annual interest on the water works bonds, issue of a.D. 1906, a special tax of (5) Five mills on each dollar, of said property so assessed or to

be assessed.

Third -- For the purpose of defraying the expenses and maintenance of a free public library ($\frac{1}{8}$) seven eights mills on each dollar, so assessed or to be assessed.

Fourth -- For the purpose of defraying the general expenses and liabilities of the City of Grand Junction, (14 $\frac{5}{8}$) Fourteen and four eights mills on each dollar so assessed or to be assessed. and be it further resolved that the City Clerk be and hereby is directed and instructed to Certify this levy to the County Clerk of Mesa County, Colorado, for levy by the Board of County Commissioners of said County as required by law.

Thereupon Alderman Davies made a motion seconded by Alderman AlKirk that said resolution be passed and adopted, upon call of roll vote was as follows, Alderman AlKirk yea, Davies yea, Lutes yea, M.C. Culloch yea, Morris yea, O'Boyle yea, Platt yea Smith yea motion carried.

Alderman Lutes made a motion seconded by Alderman Smith to adjourn without day upon call of motion said motion carried unanimously.
