The following applications for night police to fill vacancy caused by promotion of C. C. O'Neil to City Marshal were read as follows: F. Butler, W. Burrell, L. L. Counts, H. P. Barnard, and E. M<sup>c</sup>. Farland, thereupon Alderman Platt made a motion seconded <sup>by ballot</sup> by Ald. Harris to proceed to the election of a night policeman, upon call of motion said motion carried unanimously.

There were four ballots taken the final vote stood Dell Burrell two and H. P. Barnard four. The Mayor declared H. P. Barnard elected.

Attorney Greir appeared before Council upon the invitation of the Mayor for anyone present to present their petitions, he appeared in behalf of several churches of the City who had circulated petitions, and received about 400 signatures, of citizens and taxpayers requesting that the Council revoke the saloon license of James Purcell for selling liquor to minors, upon which charge he had been convicted in Police Court, Chairman Boyle of the license Committee to whom a previous petition had been referred, stated that there were only two of said committee present and they were unable to agree and asked for further time in which to report, the Committee were granted further time.

Chairman Davies reported to Council that it was necessary to purchase a small feed pump for the boilers at the pump house the probable cost to be about

\$200,00 thereupon ald. Harris made a motion seconded by ald. Platt that the water Com. be authorized to purchase the pump required, upon call of motion said motion carried unanimously.

Ramey Udlock  
Calls off bid  
for water bonds
