

Grand Junction Colo. July 23rd A.D. 1907

The City Council of the City of Grand

Roll Call Junction convened in second regular monthly session, Mayor Wentworth presiding, upon call of roll the following responded present, ald. Davies, Drew, Flynn, Hertz, Hudson, Matthews, Plank, and City Atty Rozelle, absent ald. Boyce.

Report of
Fire & Police
Committee.

Chairman Flynn of the Fire & Police Com. reported that the Com. recommended the purchase of 40 oz. rubber gaskets 40 oz. bottles of acid and 50 lbs. soda for fire chemicals and one set of harness hangers for the fire deptt. said supplies to be purchased by the Purchasing Com. They also reported unfavorable on loaning the safe at the fire hall to the Y.M.C.A. and reported favorable on the application for permit to put in a glass front at Turn Halle by Ramsey Bros. Thereupon Ald. Matthews made a motion seconded by Ald. Drew that the report of the Sta. Com. be accepted and affirmed. Upon call of motion said motion carried unanimously.

300 Inches

Hudson with the consent of his second withdrew his motion. He then offered a motion to secure 300 inches of Kannah Creek water by

Chairman Davies of the special water com. presented a contract for acceptance or rejection by Council as follows.

Contract.

Contract

Between S. M. Fagan 23rd day of July, A.D. 1907, by and between the City of Grand Junction (a municipal corporation of the State of Colorado,) herein styled and City of Grand Junction party of the first part, and Strand M. Fagan and J. S. Carnahan, parties of the second part,

Witnesseth: That the said second parties hereby agree and contract to act as special Counsel in the condemnation proceedings to be instituted by the said First Party in the District Court of Mesa County, Colorado for the purpose of obtaining possession of and title to a sufficient quantity of the waters of Kannah Creek and its tributaries in said County to furnish and supply the said City with water for its needs and for the use of its inhabitants upon the following terms and conditions, to-wit:

Said second parties are to take immediate steps in the commencement of said proceedings, and shall prosecute said suit with all due and reasonable diligence; shall give the matter their prompt and personal attention and shall prosecute said proceedings without delay, and shall in all respects use their best efforts, skill and ability on behalf of said City in the prosecution of said suit and proceedings to a final determination.

Said second parties shall meet with the City Council at any and all reasonable times the City Council may desire during the pendency of said condemnation proceedings and give advice and Counsel in relation thereto; and said second parties shall also meet with the special water committee at any and all reasonable times wherein the question of the condemnation proceedings is before said committee and shall give advice and Counsel to said committee on all matters pertaining to said suit and proceedings, and shall charge no extra compensation therefor.

In consideration of the services of said second parties to be performed as herein provided, said first party shall pay to the said second parties, the sum of (\$2500) Twenty Five Hundred Dollars in the following manner, Viz: One-third cash, the receipt of which is hereby acknowledged; One-third when a decree of

the District Court is awarded, and the remainder to be paid on the final determination of said proceedings, provided however, that the said first party reserve its right upon the making of the award for damage to the owner or owners of said water in case the said award is deemed excessive, or for any other reason in the judgement of the first party acting by and through its City Council, to elect to pay the costs in said proceedings and thereby terminate the same as provided in the statutes.

It is further agreed and understood that said second parties are to pay all their own personal expense during the pendency of said proceedings (such as traveling and hotel expenses) it being the intention of the parties hereto that the said sum of \$2500 is to cover any and all fees and expenses to be paid said second parties, but not to cover Court costs and Court expenses such as the necessary printing of briefs and abstracts, the obtaining of evidence, data and other facts and matters necessary in preparing for the trial of and the prosecution of said suit, all of which said costs and expenses are to be born by and advanced by the said first party from time to time as the same become necessary.

In Witness whereof this contract hath been executed on the part of the first party by its duly elected qualified and acting Mayor, attested by the Clerk of said City with the seal thereof authorized by resolution of the City Council duly passed, and by the said second parties the day and year above written.

Be it resolved by the City Council of the City of Grand Junction that it be, and hereby is declared and determined that it is necessary in order to supply the said City of Grand Junction and its inhabitants with a suitable and wholesome supply of water that the said City of Grand Junction take from Gunnison Creek, in Mesa County Colorado, at such suitable point or points as the special water Committee shall determine is most practicable 300 inches of the waters of the said stream; and be it further resolved that the

special water committee of this City Council attempt to obtain the consent in writing of the persons or corporations who have vested rights therein heretofore acquired residing upon said stream, or doing any milling or manufacturing business thereon, or attempt to settle with the owners of rights that may or will be injuriously effected thereby, and be it further resolved by the City Council that in the event the said special water committee is unable to obtain the consent of the said parties in writing, or settle with the parties that may be injuriously effected by the taking of the said water then and in that case the said committee shall at once notify the City Attorney and Special Counsel for the City who are directed and empowered to at once commence Condemnation proceedings in the District Court of Mesa County for the condemnation thereof as provided by law.
