Chairman Flynn of the Fire & Police Com. moved the adoption of the following Resolution.

Walks ordered

The Street & Alley Com. recommended that the following sidewalks be ordered laid, on Grand on North side between 5th & 6th, on Gunnison on South side between 2nd & 5th, East side of 7th Street from Curway on North to alley.

East side Gunnison ave 4th from Gunnison ave to alley, thereupon ald. Davies made a motion seconded by ald. Flynn that the report of the committee be sustained and that said sidewalks be ordered laid, upon call of roll the following voted yea. Ald. Davies, Flynn, Hertz, Hudson Matthews and Plank motion carried.

S & A. Com. to inspect Walks

ald Davies made a motion seconded by ald. Plank instructing The Street & Alley Com. to inspect the sidewalks along the north side White ave between 5th & 8th. streets and ascertain whether the walks are in good condition, upon call of motion said motion carried unanimously.

Extension of Pipe on Grand ave refered to Water Com.

ald Matthews made a motion seconded by ald. Hudson that the matter of extending the water main on Grand ave be refered to the Water Sewers and Light Com. for report, upon call of motion said motion carried unanimously.

Board of Health to have streets & alleys cleaned

ald. Matthews made a motion seconded by ald. Davies that the Board of Health take action to have the streets & alleys and back yards also vacant lots thoroughly cleaned up during the month of October upon call of motion said motion carried unanimously.

Contract for revising City Ordinances let to Joe W. Ruzzelle

ald. Hertz introduced the following Resolution and moved its adoption. Resolved that the contract for revising ordinances be awarded to Joe W. Ruzzelle at the price and on the terms submitted to Finance Committee, and that said Finance Committee be authorized to draw contract therefor.
