A petition signed by seventy five people residing in Crawford add. requested Council to place an are light at the intersection of Lawrence and Fairview avenues, this was referred to the Water, Sewer and light Com.

The following monthly reports of officers were read and referred to the Finance Com. City Clerk, Police Magistrate, Water Supt. and City Treasurer.

The Fire & Police Com. reported favorable upon the petition of Edwin Price to erect a small corrugated iron building on the rear of building at #542 Colo. ave. thereupon ald. Drew made a motion seconded by ald. Matthews that the report of the Com. be accepted and the permit be granted, upon call of roll the following voted aye ald. Davies, Drew, Flynn, Hertz, Hudson, Matthews and Plank motion carried.

The Finance Com. recommended that the interest on the tax certificate held by the City Treasurer on lot 16 B117 for sewer tax owed by the County of Mesa be rebated to said County, ald.
