

Grand Junction, Colo, Feb. 2<sup>nd</sup> 1909.

The City Council of the City of Grand Junction convened in regular adjourned session at the Council Chamber in the City Hall in said City at the hour of 8 P.M. pursuant to adjournment, Mayor Wentworth presiding, upon roll call the following responded present, Aldermen W. D. Davies, W. C. Bayer, M. H. Flynn, M. Hertz and C. T. Hudson also present City Atty Joe W. Rozzelle and City Clerk John M. Conley. absent Aldermen A. P. Drew, J. B. Matthews and J. C. Plank.

Roll Call

The City Clerk presented and read to the Council the proof of publication of the Ordinance introduced by Alderman A. P. Drew, entitled, "an Ordinance no. — to amend 'an



Ordinance entitled, "An Ordinance No. 152," etc. as ordered published for two weeks, at the last regular meeting of the Council, January 12th, 1909.

Alderman Davies moved, seconded by Alderman Hudson that the proof of publication as read by the Clerk be received, accepted and placed in file.

Said motion being put to vote, the Clerk called the roll and each alderman voted as follows:

W.D. Davies yea, W.C. Boyer yea, M.H. Flynn yea, C.F. Hudson yea. whereupon the Mayor declared the motion carried and ordered said proof of Publication placed in file.

Ordinance

#153 passed and adopted

Alderman Boyer moved, seconded by Alderman Hertz that the Ordinance as published be taken up for passage.

The roll call on said motion resulted as follows: W.D. Davies yea, W.C. Boyer yea, M.H. Flynn yea, M. Hertz yea, C.F. Hudson yea, a majority having voted in favor of said motion, the Mayor declared the motion carried, and the Clerk was ordered to read the ordinance in full.

Whereupon it was moved by Alderman Davies, seconded by Alderman Boyer, that the Ordinance as read do now pass.

The vote being called for, a roll call was ordered, and each alderman, as his name was called, voted as follows: Alderman W.D. Davies yea, W.C. Boyer yea, M.H. Flynn yea, M. Hertz yea, C.F. Hudson yea. A majority of the Alderman having voted in favor of the motion, the Mayor declared the motion carried, and the Ordinance duly passed.

Alderman Flynn moved seconded by Ald. Hudson <sup>the ordinance</sup> be numbered 153 upon call of motion said motion carried unanimously.

Alderman Flynn moved seconded by Ald. Boyer that the sum of \$310<sup>00</sup> be transferred from the General Fund to the Fire Fund, upon roll call the following voted yea, Alderman W.D. Davies, W.C. Boyer, M.H. Flynn, M. Hertz, C.F. Hudson. Whereupon the Mayor declared the motion carried.
