2nd Ballot resulted as follows 4 votes for E. W. Gilbert and 4 Blank votes. E. W. Gilbert having received a majority of ballots cast, was declared elected to fill the position of Driver for Fire Dept.

Council proceeded to ballot to fill the position of City Physician

2nd Ballot C. W. Reed 1 vote W. S. Day 7 votes W. S. Day having received a majority of the ballots cast was declared to be elected to serve as City Physician

Moved by Ald. All the Aldermen having voted yea, the motion was declared carried.

Council took a recess for five minutes. Upon reconvening after recess, the Mayor ruled Ald. Campbell's motion out of order and directed Council to proceed to vote by ballot.

To the Honorable Mayor and members of the city council of the city of Grand Junction Colorado.

As city treasurer of the city of Grand Junction Colorado for the term of two years from Apr. 15th 1907 to Apr. 19th 1909 I have deposited the funds of the city in the following banking houses Mesa Co. Nat. Bank; Grand Valley National; Union Trust Banking Co. and sufficient funds in Knott's Bank in New York to cover interest on Water Bonds made payable at that place of banking business.

Following resolution was introduced and read:

Be it resolved by the city council of the city of
Grand Junction Colorado, that for the purpose of giving
the different saloon men, and Family Liquor Store of
the city an opportunity of disposing of their fixtures,
Stock of goods, Leases on their buildings &c. and in as
much as the Local Option law of the state, under which
the question of creating Dry territory in the city
of Grand Junction was submitted at an election
held in this city on Apr. 6th A.D. 1909, provides that
the results of said election shall not go into force
and effect until a period of thirty days after
said election has elapsed. It is therefore the sense
of this council that we do not desire to take any
man's property without due process of law, and it
is the further sense of this council that we desire
to be as near as possible within the meaning and
intent of the said above Local Option law above referred
to: and it is the further sense of this council that
the different saloon men and Family Liquor Store
referred to, be authorized and permitted to carry
on and conduct, operate and maintain their respective
places of business within said city for a period of
thirty days after said election and until the 6th day
of May A.D. 1909"
