The following order in connection with issue of \$5000 Refunding Bonds was introduced by Ald. Magill.

It is hereby ordered that said issue of bonds, before delivery to the purchaser thereof, be forwarded by the City Clerk of said city to the State Auditor of the State of Colorado, requesting such Auditor to register the bonds in a book to be kept by him for that purpose, and when so registered, the legality thereof shall not be open to contest by this City or any other person or corporation on behalf of this city for any reason whatever; and a certified copy of this order shall be furnished to the State Auditor as his authority for such registration, the sum of six dollars and fifty cents (6⁵⁰) is hereby appropriated out of any funds of the city that may be available for that purpose, as the registration fee of ten cents for registering each bond, which fee shall be paid to said Auditor.

Moved by Ald. Magill, and seconded by Ald. Gasho that order as read be passed and adopted.

The motion being put, the clerk called the roll, whereupon each Alderman as his name was called, voted as follows,
