

Grand Junction, Colo., December 8, 1909.

The City Council of the City of Grand Junction met pursuant to adjournment at 4 o'clock p.m., in the Council Chamber, City Hall, with Mayor Todd in the chair.

Roll Call Upon roll call the following commissioners responded as present: Todd, Vedder, Vorbeck, Scoville, Holmberg. Absent, none.

The following resolution was introduced and read to the Council:

Whereas, The Western Slope Securities Company, a corporation, organized and existing under and by virtue of the laws of the State of Colorado, is the owner of more than two-thirds of the following described tracts of land:

Beginning at a point where the north line of Grand Avenue in the City of Grand Junction, Mesa County, Colorado, projected east intersects the west line of said

S. W. 1/4 of N. W. 1/4 of said Section 13, thence east 1320.8 feet to the east line of the

S. W. 1/4 of the N. W. 1/4 of said Sec. 13, thence north along the said east line 686.6 feet to the intersection of the center line of

Chipeta Avenue projected east to said east line. Thence west along said

projected center line of Chipeta Avenue 1321.6 feet to the west line of said

S. W. 1/4 of N. W. 1/4 of Sec. 13, thence

south along said west line 686.6 feet to the place of beginning, containing

20.825 acres more or less; described on

the accompanying plat and dedication herewith, as Dundee Place.

Also beginning on the west line of S. W. 1/4 of N. W. 1/4 of Sec. 13, Twp. 1 S., R. 1 W., U. M. M., at the point of its intersection with the south line of Grand Avenue, Grand Junction, Colorado, at its eastern terminus; thence east parallel with the south line of said S. W. 1/4 of N. W. 1/4 of Sec. 13, according to government survey 1320 feet more or less to the east line of said S. W. 1/4 of N. W. 1/4; thence north 100 feet; thence west parallel to same south line of S. W. 1/4 of N. W. 1/4 to its west line and to the north line of Grand Avenue at its eastern terminus; thence south to the point of beginning, being shown on the accompanying plat as a part of Grand Avenue.

Also the south 12 feet of the S. W. 1/4 of N. W. 1/4 of Sec. 13, Twp. 1 S., R. 1 W.

M. M., as shown on accompanying plat.

And, Whereas, all taxes assessed against said above described property which are now due have been paid;

And, Whereas, there is no bonded indebtedness against said above described property;

And, Whereas, The Western Slope Securities Company is desirous of having the land above described, as shown on the accompanying plat, incorporated in and becoming within and a part of the City of Grand Junction, Colorado.

Now, Therefore, Be it Resolved by the City Council of the City of Grand Junction of Mesa County, Colorado, it does hereby approve and confirm the attached plat and petition and do hereby grant the said petition, and do hereby accept, declare and make the said land described in the attached plat a part and parcel of the City of Grand Junction, and included within the limits and jurisdiction thereof.

Moved by Commissioner Vedder and seconded by Commissioner Scoville that the resolution as read be adopted by the Council.

Upon call of roll, each Commissioner as his name was called, voted as follows:

Todd, yea; Vedder, yea; Vorbeck, yea; Scoville, yea; Holmberg, yea.

Resolution Adopted. All the Commissioners having voted yea, the motion was declared carried and the resolution adopted.

Bond of B.W. Vedder Com. of Water and Sewers The official bond in the amount of Two thousand dollars (\$2,000.00) of B. W. Vedder, as Commissioner of Water and Sewers, having been examined by the City Attorney and found to be in proper form, it was

Moved by Commissioner Vorbeck and seconded by Commissioner Scoville that the bond of Commissioner Vedder be approved by the Council.

Bond Approved Upon call of roll, the Commissioners voted as follows: Todd, yea; Vedder, yea; Vorbeck, yea; Scoville, yea; Holmberg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bond approved.

Bond of Wm A. Knoche, Policeman The official bond of William A. Knoche, as Policeman, in the sum of Five Hundred Dollars (\$500.00) having been examined by the City Attorney and found to be in proper form, it was,

Moved by Commissioner Vedder and seconded by Commissioner Scoville that the bond be approved by the Council.

Bond Approved Upon call of roll, the Commissioners voted as follows: Todd, yea; Vedder, yea; Vorbeck, yea; Scoville, yea; Holmberg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bond approved.

Moved by Commissioner Vorbeck and seconded by Commissioner Vedder that the City Clerk be instructed to confer with Mr. J. H. Rozelle in reference to his contract with the City for revising its Ordinances, and request Mr. Rozelle to appear before the Council at its next regular meeting.

The motion carried.

Moved by Commissioner Vorbeck and seconded by Commissioner Scoville that the Council adjourn.

The motion carried, and the Council then adjourned.
