

ADMINISTRATIVE REGULATION 2014 04-2014

INDUSTRIAL PRETREATMENT DISCHARGE PERMIT TEMPLATE – FINAL PERMIT TEMPLATE BASED ON USEPA REVIEW

Topic:

This regulation updates the Industrial Pretreatment Discharge Permit Template per §13.04.390 and §13.04.400 of Grand Junction Municipal Code (GJMC) due to a recent USEPA Region 8 review. The Template was previously approved by the City under Administrative Regulation 02-2014 due to the 2013 revision of Wastewater Ordinance Chapter 13.04. The Industrial Discharge Permit Template, as on file with the Industrial Pretreatment Division, will be used to issue future Industrial Discharge Permits and may be amended in the future.

Background and Purpose:

The purpose of this Administrative Regulation is to update the Industrial Discharge Permit Template per GJMC §13.04.390 and §13.04.400 due to USEPA requirements found in a USEPA Pretreatment Compliance Inspection performed in April 2014. Those sections provide as follows:

13.04.390 Industrial Pretreatment Program – Industrial Discharge Permits

(a) Permits Required

All Significant Industrial Users proposing to connect to, or discharge into, any part of the wastewater system shall apply for and obtain an Industrial Discharge Permit prior to commencing discharge to the POTW. A separate permit may be required for each Industrial User, building or complex of building. Such Significant Industrial Users shall immediately contact the City and obtain an Industrial Waste Discharge Permit.

13.04.400 Industrial Pretreatment Program – Industrial Discharge Permit Conditions

Industrial Discharge Permits shall be expressly subject to all provisions of this Code and all other applicable regulations, user charges and fees established by the City.

By and through the authority created in 2.12.010, the Director may interpret and implement a means to effectuate the purpose(s) of ordinances and ensure that the same are given full and reasonable effect. That process is being utilized here. <sup>1</sup>

Administrative Interpretation:

The Director hereby determines that for the protection of the general health, safety and welfare of the community, that he will, through the adoption of this administrative regulation, allow the Industrial Discharge Permit Template to be updated based on Wastewater Ordinance 13.04.

Because Federal law requires the Code to be updated the Director by and through this administrative regulation does allow the Industrial Discharge Permit Template to be updated per the USEPA requirements.

This administrative regulation is duly adopted this 1<sup>st</sup> day of July, 2014.
