

Grand Junction, Colorado, May 11, 1911.

Adjourned
Session

The City Council of the City of Grand Junction convened, pursuant to adjournment, at 4 o'clock p.m., in the City Hall, with Mayor Todd in the chair.

Upon call of roll, the following Commissioners responded as present: Todd, Vedder, Vorbick, Holmberg.

Roll Call.

Absent: Commissioner Scovill.

Acting City Attorney Tupper was present.

The following resolution, introduced by Commissioner Vedder, was read by the clerk:

Whereas, there has been created in the City of Grand Junction, Colorado, a paving district known and designated as Paving District No. 1, authorizing the paving of certain streets therein, and providing for connecting the premises abutting on said streets with the ^{city} water mains with lead pipe, all in conformity with the full details, specifications, maps and estimates heretofore adopted by the City Council of said city; and

Whereas, within said paving district there are water mains from which water is taken to some of the premises abutting on said streets by means of iron pipes; that some of the premises abutting on said streets are not connected with said water mains; that the plans and specifications adopted for said paving district provide for the connecting of the several premises abutting on said streets with the water mains with lead pipes;

Therefore, Be it Resolved, That the owners of real estate abutting on said streets, be and they are hereby ordered to connect their said several premises with the water mains with lead pipe, according to the ordinances of the City of Grand Junction, and the plans and specifications heretofore duly adopted for said paving district prior to the 16th day of June, A. D. 1911; and, in the event of failure of said owners, or any of them, to so connect their said premises with the said water mains by the said 16th day of June, A. D. 1911, the city shall make, or cause to be made, such lead pipe connections, and the cost thereof shall be charged to the prem-

ises with which the connection is made as provided in said Ordinance No. 178; and Be it further Resolved, That a notice be issued by the City Clerk and published for three consecutive days in the Daily News, a daily newspaper of general circulation, published in the City of Grand Junction, giving notice to the owners of the premises abutting on said streets, in said paving district, to connect their several respective premises with the water main in front thereof, by the 16th day of June, A. D. 1911; that said notice hereinbefore provided for shall be in words and figures as follows, to-wit:

All owners of real estate within Paving District No. 1, in Grand Junction, Colorado, abutting on the streets to be paved, and all persons interested generally, are hereby notified that under provisions of Ordinance No. 178 of the City of Grand Junction, the owners of said real estate were, by resolution of the City Council of the said city, passed May 11th, 1911, ordered to connect their several premises with the city water mains by the 16th day of June, 1911, with lead pipes, in accordance with the ordinances of said city, and the plans and specifications heretofore adopted by the City Council, for Paving District No. 1; that in the event of the failure of said owners to so connect, the City of Grand Junction will make, or cause to be made, such connections, and the whole cost of such connections will be assessed against the premises with which such connection is made, as provided by said ordinance.

The motion being put, each Commissioner, as his name was called, voted as follows: Todd, yea; Vedder, yea; Vorbeck, yea; Holmberg, yea.

Motion carried All the Commissioners present having voted yea, the motion was declared carried.

Adjournment On motion of Commissioner Holmberg, seconded by Commissioner Vedder, the Council adjourned to to-morrow, May 12th, at 4 o'clock p.m.
