

Grand Junction, Colorado, May 13th, 1911.

Adjourned session The City Council of the City of Grand Junction convened, pursuant to adjournment, at 4 o'clock p.m., in the City Hall, with Mayor Todd in the Chair.

Roll call Upon call of roll, the following commissioners responded as present: Todd, Vedder, Vorbeck, Scovill, Holmberg.

Resolution introduced Acting City Attorney Pupper was present. The following resolution, introduced by Commissioner Vedder, was read by the Clerk:

Resolution.

Whereas, Morris Haggerty is the owner of real estate situated on the west side of South Fifth street, and south of Struthers avenue continued, over which it is necessary for the sewer in Sewer District No. 3 to pass; and

Whereas, Morris Haggerty has by deed conveyed an easement over said real estate, giving the City of Grand Junction the right to construct over his said real estate the said sewer, and the right to maintain the same;

Therefore, be it Resolved, That in consideration of said grant by the said Morris Haggerty, the City of Grand Junction does hereby give, free of cost to Morris Haggerty, his heirs and assigns, the right to connect three houses on his real estate on South Fifth Street, which houses or locations are to be by him designated at any time prior to the construction of the said sewer through his said property; that the City of Grand Junction will place in its sewer, at the points designated, "Y's" with which Mr. Haggerty may connect with the said houses; provided, however, that the said Morris Haggerty, his heirs and assigns, shall not be permitted to connect more than one house with any one of the three connections.

Moved by Commissioner Vedder and

seconded by Commissioner Vorbeck that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Todd, yea; Vedder, yea; Vorbeck, yea; Scovill, yea; Holmberg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried, and the resolution passed and adopted.

Moved by Commissioner Vedder and seconded by Commissioner Vorbeck that the City Clerk be instructed to have the deed of right of way and plat of dedication of Haggerty's Fish Subdivision recorded in the office of the County Clerk and Recorder of Mesa County, Colorado.
