

Grand Junction, Colorado, September 29, 1911.

Adjourned  
session

The City Council of the City of Grand Junction convened in regular adjourned session at 4 o'clock p.m., in the City Hall, with Mayor Todd in the chair.

Roll call

The following Commissioners, upon call of roll, responded as present: Todd, Vedder, Vorbeck, Scovill, Holmberg.

City Attorney Bucklin was present.

A communication from the Pacific Lumber Agency, submitting an amended bid for wood-stave lumber, was read.

Moved by Commissioner Vorbeck, seconded by Commissioner Vedder that an order be given the street railway company to move poles as per list furnished by the City Engineer, as follows: Second street, 15 poles to be removed; Fourth street, from Main street to Colorado, 3 poles on each side to be removed, one pole on west side to be removed; Fifth street, from Main to Road, 2 poles to be removed; Sixth street, from Main to Road, 2 poles to be removed; Main street, 1 pole n.e. cor 2<sup>d</sup> & Main, 2 poles n.w. and s.e., Third and Main; 2 poles n.w. and s.e. Fourth and Main; 2 poles s.w. and s.e. Fifth and Main; 4 poles s.e., s.w., n.e., and n.w., Sixth and Main; 1 pole s. side Main, 6<sup>th</sup> to 7<sup>th</sup>; stakes to be set by City Engineer for new location of poles.

The motion being put, upon call of roll, the Commissioners voted as follows: Todd, yea; Vedder, yea; Vorbeck, yea; Scovill, yea; Holmberg, yea. All the Commissioners having voted yea, the motion was carried.

The labor account for the department of Water and Sewers, for the month of August, was read, being as follows:

The accounts having been approved by the Commissioner of Water and Sewers, it was moved by Commissioner Scovill, seconded by Commissioner Vedder, that the said accounts be allowed and warrants ordered drawn for the amounts.

The motion being put, each Commissioner as his name was called, voted as follows: Todd, yea; Vedder, yea; Vorbeck, yea; Scovill, yea; Kolmburg, yea.

Bills allowed. All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

Motion to observe Labor Day carried. Moved by Commissioner Kolmburg, seconded by Commissioner Vedder, that it is the sense of this Council that the City observe Labor Day, September 4<sup>th</sup>, as a holiday, in all departments, and that no work be done on said day, except in cases where necessary.

The motion carried unanimously.
