

Grand Junction, Colorado, September 12, 1911.

Regular meeting

The City Council of the City of Grand Junction convened in regular session at 4 o'clock p.m., in the City Hall, with Mayor Todd in the chair.

Roll call

Upon call of roll, the following Commissioners responded as present: Todd, Vorbeck, Scovill, Holmberg. Absent: Commissioner Vedder.

Minutes approved

City Attorney Bucklin was present. The minutes of the regular meeting of September 5th and adjourned session of September 7th were read and approved.

Messrs. Wentworth, Gasho and Lee, officers of the Mesa County Fair Association, appeared before the Council and spoke in reference to concessions and granting of licenses for novelties and tent shows during the week of the Mesa County Fair.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmberg, that during the term of the Mesa County Fair the City issue no licenses for novelties, merry-go-rounds, tent shows, striking machines or other special feature entertainments.
