The following Commissioners, upon call of rell, responded as present: Todd, Vedder, Verbeck, Rankin, Helmburg.

Meved by Commissioner Helmburg, seconded by Commissioner Vedder, that the Commissioner of Finance and Supplies be authorized and instructed to purchase for use in the city offices a Burroughs adding machine, style No. 372.

The metion being put, each Commissioner as his name was called voted as follows: Todd, yea; Vedder, yea; Verbeck, yea; Rankin, yea; Helmburg, yea.

All the Commissioners having veted yea, the metion was declared carried.

Meved by Commissioner Vedder, seconded by Commissioner Rankin, that the Mayor and Clerk be authorized to sign the agreement with the New Grand Junction Land and Investment Company for the laying of water mains in the Deversaux Sub-division of the City of Grand Junction.

The motion being put, upon call of roll, the Commissioners voted as follows: Todd, yea; Vedder, yea; Verbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners having veted yea, the Mayor declared the metion carried.

Moved by Commissioner Vedder, seconded by Commissioner Rankin, that when the money has been turned over to the City Treasurer for the extension of city water mains in the Devercaux Sub-division, the Commissioner of Finance and Supplies be authorized and instructed to order the necessary pipe and material for construction of same, according to the terms of the agreement between the City and the New Grand Junction Land and Investment Company.

The metion being put, each Commissioner as his name was called voted as follows: Todd, yea; Vedder, yea; Vorbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the metion carried, The following resolution was introduced and read:

RESOUTION.

BE IT RESOLVED, By the City Council of the City of Grand Junction, Colorade, that for the purpose of defraying the necessary expenses and liabilities of the said city of Grand Junction for the next fiscal year, beginning January 1, 1913, and ending December 31, 1913, there shall be and hereby is levied and assessed upon all the taxable preperty situated within the corporate limits of said City of Grand Junction, both real and personal, the following amounts for special and general taxes, to-wit:

lst. For the purpose of defraying the expenses and maintenance of the free Public Library; a tax of three-fourths of one (3-4 of 1) mill on each dellar of said property so assessed or to be assessed.

2d. For the purpose of advertising the City of Grand Junction and of festering and encouraging manufacturies and home industries, a tax of one(1)mill on each dellar of said property so assessed or to be assessed.

3d. For the purpose of defraying the necessary expenses and liabilities of said City of Grand Junction, and for the payment of interest on outstanding

bonds and warrants, a tax of twenty-four and three-fourths (24 and 3-4) mills is hereby assessed on each dollar of said property so assessed or to be assessed; and be it further

RESOLVED, That the City Clerk be and he is hereby authorized and instructed to certify to the foregoing levy to the County Clerk and Recorder, and also to the County Assessor of Mesa County, Colorado, for levy by the vote of the County Commissioners as required by the Statutes of the State of Colorado, and as provided also by the Charter of the said City of Grand Junction.

Meved by Commissioner Helmburg, seconded by Commissioner Vedder, that the resolution as read be passed and adopted.

The metion being put, upon call of roll, the Commissioners veted as follows: Todd, yea; Vedder, yea; Verbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayer declared the metien carried and the resolution passed and adopted.

A proposed ordinance, entitled "The Annual Appropriation Ordinance of the City of Grand Junction, Colorade, Providing for the Expenses and Liabilities of the City of Grand Junction, for the Fiscal Year Beginning January 1st, A. D. 1913, and Ending December 31st, A. D. 1913," was introduced and read.

Moved by Commissioner Verbeck, seconded by Commissioner Helmburg, that the proposed ordinance as read be passed for publication.

The metien being put, upon call of roll, the Commissioners veted as follows; Todd, yea; Vedder, yea; Verbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayer declared the matien carried and the proposed ordinance passed for publication.

Moved by Commissioner Verbeck, seconded by Commissioner Helmburg, that the Council adjourn.

The metion carried, and the Council then adjourned.
