

Grand Junction, Colorado, October 4, 1912.

The City Council of the City of Grand Junction convened in regular adjourned session at 4 o'clock p. m., in the City Hall, with Mayor Todd in the chair.

Moved by Commissioner Rankin, seconded by Commissioner Helmburg, that the bills as



read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll the Commissioners voted as follows:  
Tedd, yea; Vedder, yea; Verbeek, yea; Rankin, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

The petition of Jennie E. Delaplain and others, asking the Council to order cement sidewalk constructed along certain streets, referred to the Commissioner of Highways, was reported favorably by the Commissioner and he recommended that the sidewalk petitioned for be ordered constructed.

Moved by Commissioner Rankin, seconded by Commissioner Vedder, that the petition of Jennie E. Delaplain and others be granted, and that a cement sidewalk be and hereby is ordered constructed as follows: Beginning at the S. E. corner of Block 19, thence W. to the S. W. corner of Block 18, thence S. to the N. W. corner of Block 27, thence E. to the N. E. corner of Block 26, (and from the N. W. corner of Block 26 to the S. W. corner of Block 85, thence W. to the S. E. corner of Block 84, thence N. to the N. E. corner of Block 27. Also from the S. E. corner of Block 26 W. to the S. W. corner of Block 28; also from the N. E. corner of Block 40 to the N. W. corner of said Block 40; also from the N. E. corner of Block 48 to the N. W. corner of Block 48.

The motion being put, upon call of roll, the Commissioners voted as follows:  
- Tedd, yea; Vedder, yea; Verbeek, yea; Rankin, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried, and it was so ordered.

Moved by Commissioner Holmburg, seconded by Commissioner Verbeek, that the Council adjourn.

The motion carried, and the Council then adjourned.
