A communication from S. R. Schaeffer, submitting a proposal to audit the city books and accounts for the fiscal year ending December 31st, 1913, for the sum of \$375.00, was read.

Meved by Commissioner Vedder, seconded by Commissioner Rankin, that the proposal of ...

Mr. Schaeffer be accepted, and that he be employed to audit the city books for the current fiscal year.

The metien being put, upon call of roll, the Commissioners voted as follows: Todd, yea; Vedder, yea; Verbeck, yea; Rankin, yea; Helmburg, yea.

All the Commissioners having veted yea, the metion was declared earried.

A communication from Milne & Blakeslee in reference to bill of \$165.90 for use of the city trenching machine, and asking a reduction in said bill, was read.

Meved by Commissioner Holmburg, seconded by Commissioner Rankin, that no reduction be made in the bill rendered Milne & Blakeslee for use of trenching machine.

The metien being put, each Commissioner, as his name was called, veted as fellows: Tedd, yea; Vedder, yea; Verbeck, yea; Rankin, yea; Helmburg, yea.

All the Commissioners having voted yea, the Mayor declared the metion carried.

The quarterly report of the Public Librarian was submitted and read, and on metion of Commissioner Holmburg, seconded by Commissioner Rankin, the same was accepted and ordered placed on file.

The quarterly report of the Chief of the Fire Department was submitted and read, and en metion of Commissioner Vedder, seconded by Commissioner Verbeck, the same was referred to the Mayor.

The report of the City Treasurer for the first quarter of the year 1913 was submitted and read, and on metion of Commissioner Verbeck, seconded by Commissioner Vedder, the same was referred to the auditor.

The bend of P. C. Lewe as master plumber having been examined and approved by the City Atterney, it was moved by Commissioner Helmburg, seconded by Commissioner Vedder, that the bend be accepted and filed, and that Mr. Lewe be granted a license to earry on the business of plumbing.

The metien carried.

A member of the organization known as the I. W. W. appeared before the Council and stated that about 200 members of the organization would pass through the city within a few days, and asked that the Council provide food for the men.

Moved by Commissioner Vedder, seconded by Commissioner Rankin, that the Mayor be instructed by the Council to purchase enough food for the 200 members of the I. W. W. to provide two meals for them, the amount to be expended for same not to exceed \$25.00.

The metion being put, upon call of roll the Commissioners voted as follows: Todd, yea; Vedder, yea; Verbeck, no; Rankin, yea; Holmburg, no.

A majority of the Commissioners having voted yea, the Mayer declared the metion carried.

On metien of Commissioner Verbeck, seconded by Commissioner Rankin, the Council adjourned.
