

Grand Junction, Colorado, March 17, 1914.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayer Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Verbeek, Rankin, Carsen, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of March 10th and adjourned sessions of March 12th, 13th and 14th were read and approved.

A communication from the Commissioner of Finance and Supplies was read, reporting a large number of water users delinquent in the payment of water rentals.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that the Commissioner of Water and Sewers be instructed to shut off the water from all users who are delinquent over one quarter at once, and from all who are delinquent one quarter on March 20th.

The motion being put, each Commissioner, as his name was called, voted as follows: Cherrington, yea; Verbeek, yea; Rankin, yea; Carsen, no; Holmburg, yea.

A majority of the Commissioners having voted yea, the Mayor declared the motion carried.

The monthly report of the City Weigher having been examined and approved by the Mayor, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Verbeek, accepted and ordered placed on file.


The motion carried.
