The metion being put, each Commissioner, as his name was called, veted as fellows: Cherrington, yea; Verbeck, yea; Rankin, yea; Carson, yea; Helmburg, yea.

All the Commissioners having veted yea, the Mayer declared the metion carried and the bill allowed.

The fellowing resolution was introduced and read:

WHEREAS, it appears from the records on the books of the County
Treasurer that M. O. Delaplain bought in certain tax sales on November 23d, 1903, under Sewer Districts No. 1 and 2, amounting to
\$51.54, which amount was paid into the City Treasury; and

WHEREAS, it appears that said tax sales were cancelled on the records of the County Treasurer and the installments paid annually on said assessed property until so paid in full, the City thereby receiving \$51.54 on these Sewer Districts more than these districts were entitled to; and

WHEREAS, the books of the City show a surplus as received after all bonds of these sewer districts were paid, and said surplus stands to the credit of an account designated as Special Sewer Fund; be it therefore,

RESOLVED, that the City Clerk be instructed to issue a warrant on said Special Sewer Fund, payable to M. O. Delaplain for the amount of said \$51.54, as appears to be everpaid in said Sewer Districts No. 1 and 2.

Moved by Commissioner Verbeck, seconded by Commissioner Carson, that the resolution as read be passed and adopted.

All the Commissioners having voted yea, the Mayor declared the metion carried and the resolution passed and adopted.

Meved by Commissioner Rankin, seconded by Commissioner Verbeck, that Mr. Else be allowed Thirty (\$30.00) Dellars in settlement of claim for damages sustained on North Avenue.

The metion being put, each Commissioner, as his name was called, veted as follows:

Cherrington, yea; Verbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea. All the
Commissioners having voted yea, the motion was declared carried.

On metion of Commissioner Rankin, seconded by Commissioner Verbeck, the Council

adjourned.
